Financial Aid Terms and Conditions

ELIGIBILITY Aid is available for payment only if you have been officially admitted (not conditionally). Eligibility is contingent on meeting Satisfactory Academic Progress (SAP) policies.

ENROLLMENT Financial aid offered is based on full time enrollment and may be adjusted for part-time enrollment.

DISBURSEMENT When the university prepares your disbursement, your aid will be applied towards your university account for allowable institutional charges. Any funds remaining will be sent to you by check or direct deposit.

REPAYMENT If you received a grant payment and your enrollment status is reduced during a term, you may be billed for any overpaid amount. Withdrawal from one or more courses may result in cancellation or repayment of part or all of your aid and may jeopardize future aid eligibility due to not meeting SAP.

TUITION FEE ASSISTANCE If you received tuition fee assistance in the prior term, the Office of Financial Aid and Scholarships assumes you will continue to receive those funds for the remainder of the award year. If this assistance has changed or if you have assistance from any source not included on your financial aid award, you must notify the Office of Financial Aid and Scholarships. Receipt of these funds may result in an adjustment of aid initially offered.

CAL GRANT If you received a Cal Grant for the prior academic year, then it may be assumed for the current year using an estimated Cal Grant award. This estimate does not guarantee eligilibity and Cal State San Bernardino reserves the right to adjust/and or cancel your Cal Grant award based on any changes in your total income, changes in household size and/or any updates received by the California Student Aid Commission.

PELL GRANT Eligibility is based on full time enrollment and may be adjusted for part time status. Eligibility is limited to a lifetime maximum of 600%. Credential students must be enrolled in at least six Pell eligible units per term. The list of eligible courses is located on the Office of Financial Aid and Scholarships website under "Types of Aid -- Credential Students."

LOANS Undergraduate. Credential and 2nd Bachelor students must be enrolled in at least six units to receive funds. Graduate students must be enrolled in at least four graduate level units (a 500 or 600 level course) or six units of lower division course work.

AID ADJUSTMENT AND CANCELLATION Cal State San Bernardino reserves the right to adjust or cancel financial aid awards at any time without notice. If reducing or canceling aid causes a balance due (billing), students are responsible for payment. Adjustments or cancellation of financial aid can be caused by, but are not limited to, one or all of the following reasons:
• Eligibility error either by student or the Office of Financial Aid and Scholarships

- Changes in availability of funding
- Changes in a student's financial need
- Changes in state residency
- Changes in marital or academic status
- Student's failure to comply with state, federal and/or university regulations
