ON OCTOBER 12, 2015, MONDAY, AT 2133 HOURS, CSUSB POLICE RECEIVED CALL OF A FEMALE WHO HAD HER PURSE TAKEN FROM HER WHILE SITTING AT A BENCH ON THE SOUTH/EAST SIDE OF THE ADMINISTRATION BUILDING.  THE SUSPECTS WERE BOTH DESCRIBED AS HISPANIC ADULT MALES. THE MALE THAT APPROACHED THE VICTIM WAS DESCRIBED AS HAVING A DARK COMPLEXION AND APPEARED YOUNG. HE HAD DARK, STRAIGHT HAIR THAT WAS APPROXIMATELY THREE INCHES LONG. HE WAS WEARING A GRAY SHIRT WITH AN UNKNOWN PRINT AND DARK COLORED SHORTS TO HIS KNEES. NO TATTOOS OR SCARS WERE NOTICED.
