The DoD is seeking rising junior and senior (third and fourth year) undergraduate and graduate students who are interested in full-ride scholarships for concentrated studies in information assurance. Students selected for the program will receive full tuition support and an annual undergraduate stipend of \$22,500 and \$30,000 for graduate students.

Application deadline is May 15, 2017.

Minimum Eligibility Requirements

- > 18 years of age
- U.S. citizen
- Ability to pass federal job clearance requirements and security background investigation
- Full-time CSUSB junior or senior undergraduate, first or second year graduate
- ➤ 3.2 GPA for undergraduate or 3.5 for graduate students
- Pursue an academic program in Cyber Security at CSUSB with no outside employment

Application Requirements

- Resume
- A separate 8.5 x 11 page with the applicant's name and school, highlighting recognitions, honors and awards
- A separate 8.5 x 11 page assessment of your knowledge and ability of 6 competency areas
- ➤ 2 letters of reference from (professional and academic), addressing the following factors:
 - The relationship of the referee to you
 - The length of the relationship
 - o An assessment of potential for academic success and fulfillment of degree requirements
 - An assessment of your knowledge and ability over 6 competency areas
- Agreement to accept a federal appointment and intern assignment under the DoD or a federal hiring authority (preferences for employment agency or location are not guaranteed)
 - This requires students to agree to serve one year of service to the DoD, upon graduation, for each year of scholarship received, in addition to an internship
- Agreement to accept assignments that require travel or changes in duty stations


