Description of Outcomes for incidents with no investigation		
Stalking	Non-Affiliate	Student reported an ex-boyfriend was stalking her. Resources were given to student; UPD and Advocate.
Stalking	Non-Affiliate	Student only requested UPD assistance. 7-day Stay Away Order issued. Assistance from the Advocate also given.
Stalking	Non-Affiliate	Student reported being stalked by a non-affiliate. The advocate was offered to assist her.
Dating Violence	Non-Affiliate	Student involved in an incident of dating violence with a non-affiliate. UPD assistance was offered, as well as the support of the advocate.
Dating Violence	Non-Affiliate	Student reported dating violence with a non-affiliated person. UPD assistance was offered, as well as the support of the advocate.
Dating Violence	Non-Affiliate	Received report from UPD regarding a dating violence involving a non-affiliate threatening a student with a weapon. Student was given resources and options, but still remained in the relationship. Student was linked to the CSUSB Advocate for assistance.
Dating Violence	Non-Affiliate	Report of a dating violence incident with a student and a non-affiliate. Multiple attempts were made to contact the student, but the student declined all offers for support and resources.

Dating Violence	Unknown	UPD responded to an incident of dating violence where the unknown suspect fled and was not able to be identified. The complainant was offered assistance and support from the advocate. Housing accommodations were declined.
Domestic Violence	Non-Affiliate	A student reported that she was involved in a domestic violence situation involving the father of her child. A police report was made, and the student was referred for support and assistance from the advocate.
Domestic Violence	Non-Affiliate	Student reported to a faculty member that she had been involved in an incident of domestic violence with her spouse. An academic accommodation was given to her, as well as being referred to the advocate for support and additional resources.
Domestic Violence	Non-Affiliate	Student reported being involved in a domestic violence incident with a non-affiliate. The student was referred to the advocate for support and resources.
Domestic Violence	Non-Affiliate	Student reported being homeless due to domestic violence with her father. Resources were offered and the student was referred to the CARE team for assistance.
Sexual Misconduct	Non-Affiliate	UPD informed the Title IX office of an anonymous complainant who reported that she was sexually assaulted by a non-affiliate. A restraining order was sought and the UPD referred the student to the advocate for further support and resources.
Sexual Misconduct	Non-Affiliate	A student reported that she was sexually assaulted by a non-affiliate. UPD was called and the student was also referred to the advocate for support and resources. Student declined housing or academic accommodations.
Sexual Misconduct	Unknown	A student reported being touched inappropriately (sexual battery) during an event on campus. UPD responded and took a report, but was unable to identify the respondent. The student was offered support and resources from the advocate.
Sexual Misconduct	Unknown	A student reported a sexual battery on campus by an unknown individual. A Timely Warning was sent out by UPD. The student was referred to the advocate for additional support and resources.

Sexual Misconduct	Unknown	A professor reported a student informed him that she was sexually assaulted by another student (unknown). The student refused to meet with Title IX, but was offered resources and support.
Sexual Misconduct	Unknown	A student reported being sexually assaulted while incapacitated, but was unsure of what occurred. Student was offered support and resources from the advocate.
Sexual Misconduct	Unknown	Student reported to her professor that she had been sexually assaulted during the Summer and was having issues with financial aid. Title IX assisted her with academic accommodations, meeting with the advocate, and referring her to the Counseling and Psychological Services.

Descriptions for Investigations with Insufficient Evidence		
Sexual Misconduct	Student	Insufficient evidence to conclude that sexual misconduct occurred. Complainant did not recall much information; Respondent did and also brought forward evidence (text messages).
Sexual Misconduct	Student	Insufficient evidence to conclude that sexual misconduct occurred. Complainant asked the Respondent to stop to change positions, and the Respondent obliged. Both parties continued to have consensual sex.
Stalking	Student	Complainant stated she did not feel Respondent was stalking her. Respondent was not found to be in violation of stalking because Complainant actively engaged in a friendship with Respondent.
Stalking	Student	Complainant stated he did not feel threatened or in fear by the Respondent. The Respondent, a student, was trying to reach his Professor (Complainant) to discuss his academic standing.
Sexual Misconduct	Student	Complainant did not participate in the investigation; Respondent provided evidence to conclude that the Complainant was actively engaged in sexual activity between the two parties.
Sexual Misconduct	Student	Investigator determined the Sexual Misconduct allegation was retaliation for being named as a respondent in a separate case. Insufficient evidence provided.
Sexual Misconduct	Student	Investigator determined both students involved were incapacitated and there was insufficient evidence to conclude sexual misconduct occurred.
Sexual Misconduct	Faculty	Investigator determined there was insufficient evidence to conclude sexual misconduct. Complainant refused to participate and contacted the investigator to inform her that she did not tell the reporting party she was a victim of sexual misconduct by the respondent.
Dating Violence (pending beginning)	Student	Complainant admitted that she pushed the respondent first and respondent attempted to stop her. Complainant did not feel in fear of Respondent causing her any serious bodily harm.
