**Attention Students:** Read the following options and select the one that fits your situation. These are the only exceptions to enroll in less than a full course of study with USCIS. Students are also required to complete a Leave of Absence form with their department if they are taking a year (undergraduate) or one quarter (grad) off.

### FULL-TIME COURSE LOAD REQUIREMENT

ACADEMIC LEVEL	MINIMUM COURSE LOAD
English Language Program	All Core Classes
SA USA/ APP	12 units per quarter
Undergraduate	12 unites per quarter
Graduate	8 units per quarter

\*Only one online class can be used per quarter to meet full-time requirement\*

### EXCEPTIONS TO A FULL COURSE OF STUDY

#### ILLNESS OF MEDICAL CONDITION

A student may waive a full course load or take a quarter off if it is required by a licensed medical doctor, psychologist or psychiatrist. If the student is going through a difficult time in their life (i.e. divorce, family death, etc.) and feel they cannot take a full course load should obtain a note from a licensed psychologist or psychiatrist.

#### ACADEMIC DIFFICULTY

Initial difficulty with the English language, Unfamiliar with reading requirements, Unfamiliar with U.S. teaching methods, and Improper course level placement are the only acceptable reasons to reduce a course load due to academic difficulty. Each category may only be used the first quarter of the student's program, **not** institution.

#### LESS THAN FULL-TIME LOAD NEEDED TO GRADUATE

A student may request to waive a full course load in their final quarter of study if they have need to compete fewer courses than the required minimum course load. Undergraduate students are required to enroll in 6 units. Graduate students working on their thesis, project or preparing for the comprehensive exam may also request to waive a full course load. Students can fall out of status if they do not submit a waiver request form with the Center for International Studies and Programs.

#### QUARTER OFF

Students are entitled to a vacation quarter if they have completed three (3) consecutive quarters in an academic year as a full-time student. A vacation quarter allows students to remain in the U.S. without having to enroll in courses.

Otherwise, to take a quarter off, you must leave the country before classes start and not return before 30 days before next classes start. More than 5 months outside the U.S. cancels the I-20. Then you must enroll in the next available quarter, send plane tickets to request a new I-20 and pay the I-901 fee again.
