INTRODUCTION

The Inland Empire Research Consortium (IERC) is pleased to present the 2001 San Bernardino County Special Zone Edition of the Inland Empire Annual Survey. Reflecting a high priority of SANBAG (San Bernardino Associated Governments), one of our major sponsors, this Special Zone Edition presents the annual survey findings for San Bernardino county, broken down into four regions: East Valley, West Valley, Desert, and Victor Valley. An annual Riverside County Special Zone Edition has also been prepared per request of RCTC (Riverside County Transportation Commission), another of our major sponsors. Further, the main Inland Empire Annual Survey report compares the results for the two counties.

The IERC represents a partnership between researchers from the Institute of Applied Research and Policy Analysis at California State University San Bernardino (CSUSB) and the Center for Social and Behavioral Sciences Research at University of California Riverside (UCR). IERC is committed to promoting regionalism and cooperation, and to projecting the Inland Empire onto the radar screen of "significant actors" in the State. It is our hope that the Inland Empire Annual Survey will continue to be a valuable resource for initiating community discourse and helping to inform public officials and citizens.

THE QUESTIONNAIRE

Questionnaire items reported in this Special Zone Edition were selected on the following basis: Several questions were incorporated from previous annual surveys of Riverside and San Bernardino counties for the purpose of tracking changes over time in the residents' perceptions about their quality of life and economic well-being, their views about the pressing issues of the day, and their ratings of public services and agencies. In addition, a number of standard

demographic questions were included for tracking purposes and for cross tabulation of findings. Tracking questions provide public agencies and business with trend data often needed in policy making and outcome assessments. Finally, the researchers also added proprietary questions that address data needs of special relevance to the contributors to this survey.

A draft copy of the questionnaire was submitted to the sponsors for their approval and modified where warranted. A Spanish version of the questionnaire was also produced. The survey instrument was then pre-tested, and some minor changes to the wording and order of some items were made. The questionnaire is attached as Appendix I.

SAMPLING METHODS

Telephone survey respondents were randomly selected from a comprehensive sample frame consisting of all telephone working blocks which contain residential telephone numbers in Riverside and San Bernardino Counties. This is a standard random sampling approach for studies of this nature. In order to ensure accuracy of findings, 2,695 residents were surveyed from the two-county area for a 95 percent level of confidence and an accuracy of approximately plus/minus 1.9 percent for overall two-county findings.

Sample size of the two counties varied due to the over-sampling of some of the regional zones in San Bernardino and Riverside Counties, and also due to the fact that the City of San Bernardino contracted for a higher sample size so that generalizations could be made to the city as whole. As a result, 1,548 residents of San Bernardino County were surveyed, for an accuracy of at a plus or minus 2.7 percent and 95 percent level of confidence.

To ensure an acceptable level of accuracy of findings within each of the San Bernardino County regions (East Valley, West Valley, Desert, and Victor Valley), a sample size of at least 200 respondents was required. The accuracy of the zone data presented in this Special Edition, however, varies depending on the number of respondents sampled within each zone. Specifically, each zone has a 95% level of confidence and an accuracy better than plus or minus 7%. Due to weighting considerations to remove the effects of the over-sampling, the reader will note a discrepancy between the actual sample size and the total number of cases reported in the data tables for San Bernardino County as a whole. For the list of cities within each zone, see Appendix II.

Telephone interviews were conducted by the Institute of Applied Research at California State University, San Bernardino using computer assisted telephone interviewing (CATI)

equipment and software. The surveys were conducted between November 14, 2001 and January 15, 2002.

INTRODUCTION TO FINDINGS

As a preface to the zone findings, a few general comments are in order. As highlighted in the Inland Empire Survey Annual Report dealing with the two-county area, the commonly held belief that San Bernardino and Riverside County residents differ dramatically in attitudes, opinions, and beliefs is generally dispelled. Instead two county residents were found to be remarkably similar in their ratings of the Inland Empire as a place to live, perceptions about the economy and quality of life, evaluations of public services, views about major issues, and beliefs about social and political philosophies. But as this report illustrates there are more differences within each county than there are between counties.

This report includes a sufficient number of data points (5 surveys, conducted from 1997 to 2001) to conduct more extensive and more valid trend analyses than in previous reports, both for the two-county area as a whole and for each individual county.

THE FINDINGS

COMMUTING AND TRANSPORTATION ISSUES

OVERVIEW: The most "popular" strategy for reducing traffic congestion is any strategy which allows respondents to continue driving their cars (building and/or widening freeways, and building/maintaining/repairing local streets and roads). Desert Zone respondents were not as concerned as respondents in the other zones about building freeways, but rather showed a preference for repairing and maintaining existing streets. Most respondents spend less than 1 hour commuting to and from work each day. But a significant number of San Bernardino County residents report their commuting time to be 2 hours or longer each day. These findings are consistent with the past three years' results. The vast majority of San

Bernardino County residents commute to work within their own county, although over a quarter of West Valley respondents report working in Los Angeles County.

The majority of respondents within all four zones report total commuting times (to and

from work) of less than 1 hour (Table 1), with the highest proportions of such less-than-one-hour commuters in the Desert Zone (72%) and the lowest number of less-than-one-hour commuters now being reported in West Valley and Victor Valley (56%).

Put another way, there are significant differences in total average commute time for the four zones: East Valley, 51 minutes; West Valley, 63 minutes; Victor Valley, 56 minutes (a significant decrease from 80 minutes reported last year), and Desert, 41 minutes.

Although a large majority of respondents report commuting a total of less than one hour each day, a significant number of respondents commute for longer times. Indeed, many San Bernardino County respondents commute for over two hours (12 % of East Valley, 19% of West Valley, 17% of Victor Valley – down from 27% last year -- and 12% of Desert respondents). Longer commuting time, of course, takes its toll in terms of personal lifestyle, individual costs for gas and maintenance, implications for energy consumption, and county and state costs for the required road improvements and maintenance.

Where do San Bernardino County residents work? Most respondents work within their county. But the West Valley Zone continues to register the highest amount of inter-county commuting, with 40% traveling outside the county (the largest group, 26%, to Los Angeles County). These results are almost an exact duplicate of last year's results.

In another transportation-related question, respondents were read a list of 5 transportation strategies and asked to indicate which one strategy they felt was the *most* important in terms of improving traffic conditions. Although there may be some regional differences, Table 2 (next page) emphasizes strongly the overall preference of San Bernardino County respondents for building and widening freeways. These preferences for increasing freeway capacity have been

noted in Annual Surveys over three years. Repair and maintenance of existing streets and roads is also mentioned by a significant number of respondents, particularly those in the Desert Zone. But when the data from two categories dealing with *local streets and roads* ("repair and maintain existing streets and roads" and "build and/or widen local streets and roads") are combined, it is clear that respondents' primary concern is to improve/enhance traffic on local roads.

In either case, respondents are still looking for strategies which allow them to drive (without additional cost such as toll roads). It is noteworthy that the other available options are not generally well received, including strategies involving public transportation (whether rail or bus) and toll roads.

Finally, a question was posed regarding whether respondents would use a planned daily train service from Redlands to San Bernardino and "destinations beyond." Only East Valley

respondents appeared to support this effort (59%). What are their preferred destinations? Within East Valley, 34% of respondents wanting to use the train service said they wished to go to San Bernardino and another 28% said they wished to take the train to Los Angeles. In contrast, the majority of West Valley respondents (59%) indicated that they would *not* use such a service, although about a third who *would* use the train would travel to San Bernardino and about a quarter would travel to Los Angeles.

MEASURE I QUESTIONS

OVERVIEW: The vast majority of respondents in all zones report little use of the public transportation projects which have been funded by Measure I (Metrolink and local bus service), a measure respondents continue to support. Respondents seem supportive of using the revenues for any and all transportation improvements offered, however respondents uniformly agree that making local street improvements is the highest priority.

San Bernardino County residents were asked a series of items regarding Measure I. Unlike last year, where the Measure I questions primarily addressed awareness, this year's questions focused primarily on usage. Specifically, respondents were given the question: "Measure I is San Bernardino County's half-cent sales tax for transportation, which was approved by voters in 1989. Have you used any of the following Measure I-funded projects within the past year?"

Table 3 shows that many respondents within all zones report using the Interstate 10 carpool lanes and State Route 210. One would expect this finding since these are two of the major arteries heading west. It is noteworthy, however, that the reported usage of State Route 210 was as high as it was given that it just opened in August of 2001. In contrast, the Measure I funded public transportation projects (Metrolink and local bus service) were relatively less utilized. Although State Route 71 and Bear Valley Road are largely used by those who live in or near those regions, a significant number of respondents outside the areas also report using these

roads. In fact, all of the regional projects are used by respondents throughout the county.

The next question dealt with continued support for the Measure I half-cent sales tax (if an election were held today). Support for the measure is clear in all four zones, ranging from 58% support among Desert respondents to a high of 73% support among West Valley respondents, with 66% support in the other two zones.

Respondents were also asked how important it would be for Measure I funds to be spent on more freeways, more bus service, more Metrolink service, or more local street improvements. Respondents seem willing to support using the revenues for *all* transportation improvements, however respondents uniformly agree that making local street improvements is the highest priority. Following is a table summarizing preferences:

When these findings are linked to other selected findings in this report, there might appear at first glance to be some contradiction. For example, relatively few respondents

indicated that "increasing public bus service frequency and routes" is the most important transportation improvement strategy to pursue (Table 2), and relatively few report using their local bus service (Table 3). Yet a large proportion (40% – 45%, depending on the zone) indicate that it is very important that the new Measure I revenue be spent on more bus service (Table 4). The same seeming contradiction holds for Metrolink service. But these apparently disparate results may simply indicate an artifact of the survey methodology. Specifically, the rankings of importance reported above do not force the respondent make a choice between competing transportation improvement strategies. In the abstract, therefore, respondents are likely to consider *all* transportation improvement strategies worthwhile unless they are forced to make a choice among competing solutions to the problem of traffic congestion (as was done in earlier questions). In summary, combining the results of the transportation questions already addressed

in Tables 2 to 4, respondents have, indeed, made a choice. The bottom line is this: The automobile culture is alive and well in California.

In answer to the question: "What level of voter approval should be required to pass special local taxes, such as taxes for schools, libraries or transportation?" respondents predominantly indicated that a two-thirds level of voter approval should be required (Table 5). The same trend held when performing the analysis for registered voters ONLY.

CALL BOX QUESTIONS

OVERVIEW: Most respondents have not used call boxes due to the fact that they did not experience an emergency. Cell phone use is increasing as a method for summoning help. But respondents still overwhelmingly see the need for call box availability.

In the 1998 Inland Empire Annual Survey, respondents were asked whether they had used

a call box within the last two years. Very few reported having used them. And of course, that was not surprising since call boxes are only to be used in emergency situations such as vehicle breakdowns or accident reports. This year the results are generally the same. The zones reporting the highest usage this year were the Desert and East Valley zones. The reported use of call boxes by Victor Valley respondents dropped dramatically to the lowest usage among the four zones (13%).

Again, putting these seemingly low figures in perspective, most of those respondents indicated that they hadn't used a call box because there was no need to do so -- their vehicle had not broken down. Of those who experienced an emergency situation, how did they get help? Clearly cell phone use has increased significantly over time, particularly in the Victor Valley and the Desert zones.

To clarify for readers comparing this table with the Appendix, both numbers and percentages of respondents are shown.

Respondents were asked whether they had experienced any problems when using the call box, and the vast majority of call box users in all zones reported having no problem at all. There

were too few complaints registered to draw any meaningful conclusions as to particular problems with the call boxes.

Regardless of recent call box use (or lack of use), the overwhelming majority of zone respondents feel that maintaining call boxes is of high priority for the region (84% – 88% in each zone). Clearly, call boxes are seen as a form of "insurance" – respondents hope they won't need them, but want them available nonetheless.

RATINGS OF THE COUNTY

OVERVIEW: Within each zone, the majority of residents rate San Bernardino County as a good place to live, citing nice living area, good climate/weather, and "not crowded" as important factors in their evaluation of county life. Affordable housing is increasingly cited as one of the "best things" about living in the county. Smog and high crime/drugs continue to be cited as the worst thing about living in the county in all zones. Traffic congestion is also

high on the list of "worst things" in the West Valley area, as is lack of job opportunities for the Victor Valley and Desert Zones. But the variability of responses is high in all zones and many respondents state that they either "don't know" or find "nothing negative" about living in the county.

As has been the case since the inception of the Inland Empire Annual Survey in 1997, the majority of zone residents rate San Bernardino County as a "fairly good" or "very good" place to live. It is encouraging that ratings are showing a general trend of improvement over time, especially in the East Valley, Victor Valley, and Desert Zones. West Valley Zone respondents

continued to give the County the highest ratings, and this year Victor Valley residents match that feeling about the county as a "good place to live." As in previous years, East Valley residents' ratings were the lowest of all zones, however the percentage rating the county as "very good" or "fairly good" has increased significantly during the past year, and now is only slightly lower than ratings given by Desert Zone respondents.

To help place the above findings in perspective, respondents' were asked to indicate the one BEST and one MOST NEGATIVE thing about living in the county. One of the more interesting findings has to do with how San Bernardino zone residents view affordable housing in the region. Until last year's survey, this wasn't even on residents' "radar screen" of best things about the county. Last year affordable housing was cited by a significant number of citizens, and this year's data show the same thing, especially in West Valley and Victor Valley. Of course, as shown in Table 10, affordable housing does not lead the list of best things about living in San Bernardino County. Rather, the standard factors of "good area, location, scenery" and "good climate, weather" are cited most frequently in all but the West Valley Zone, in which affordable housing is mentioned by a few more people than good climate and weather. In addition, the fact that the area is "not crowded" is a plus for Desert and Victor Valley Zone residents.

Last year, when zone residents were asked to respond to the question "In your opinion what is the ONE most negative thing about living in the county," high crime led the list of complaints *in all zones*. This, surprisingly, was the case even in the Desert Zone, an area not typically known for crime. This year the findings have changed somewhat in that high crime

was mentioned about equally as often as smog. That is the case for all zones other than West Valley in which there is a clear distinction: smog is mentioned more often than high crime. But if the category "high crime" is combined with "drugs," then even in this zone the most negative aspect about living in the county is considered to be crime. Although this is clearly a problem which policy makers should (and do) address, it must be noted that the figures have decreased from last year in all zones: from 32% to 18% in East Valley, from 16% to 11% in the West Valley, from 13% to 9% in the Victor Valley, and from 15% to 6% in the Desert.

In the 1999 report, we had noted that smog/air pollution had dramatically disappeared as a highly salient negative thing about county life in the minds of respondents. Last year it returned as a pressing concern in two of the four zones (East and West Valley). This year it appears to be a concern in all zones. The figures for East and West Valley are virtually unchanged from the 2000 Annual Survey, however the figures for Victor Valley and Desert have shown an increase which is within the margin of error, but just barely.

A few final comments about the "negative things" noted by respondents: there is a high amount of variability in responses in all zones, and many respondents either indicate that they "don't know" what is the most negative thing or mention that there is "nothing" negative about living in the county. Traffic congestion continues to be a concern for West Valley respondents. Lack of entertainment and lack of sufficient job opportunities are issues for Victor Valley respondents, and the lack of job opportunities is also an issue for Desert respondents.

FEAR OF CRIME AND CRIME-RELATED ISSUES

OVERVIEW: Respondents remain fearful of crime, however the level of fear has sharply

diminished, particularly within the East Valley, West Valley, and Victor Valley areas.

In most past surveys, East and West Valley respondents expressed a higher level of fear of being the victim of a serious crime (such as a violent or costly crime) than respondents in the Victor Valley and the Desert regions. That has not changed. The "big news," however, is that the level of fear has significantly decreased this year. Supporting this finding is the fact that fewer respondents mentioned high crime as the most negative thing about living in the county (noted earlier in this report). Of course, the data have shown over the years a significant amount of variability, particularly in the East Valley. In any event, these findings are encouraging, and are hopefully the beginning of a positive trend.

ECONOMIC EVALUATIONS AND FUTURE PROSPECTS

OVERVIEW: With the exception of Victor Valley, zone residents are less "impressed" with the county's economy than they were in previous Annual Surveys. In three of the four zones the majority of residents rated the local economy as only "fair." Only West Valley respondents broke this pattern, with the majority of respondents rating the economy as "good." Yet the vast majority of zone residents indicate that their personal family finances have either improved or stayed the same when compared with the previous year. And the picture of the County's economy is further mixed in that respondents in all four zones expect to be better off by next year.

As one would expect, the downturn in the national economy has had an impact on zone residents. The only exception to this trend appears to be in the Victor Valley region, where there was a slight increase in the percentage rating the economy in the county as "excellent" or "good." But in all zones, the majority of respondents rate the economy as either "fair" or "poor," with the most-often mentioned rating being "fair" in all but the West Valley Zone (in which it is "good"). Further, a substantial number of respondents stated that the economy is "poor" (17% in East Valley, up from 13% last year; 11% in West Valley, up from 5% last year; 17% in Victor Valley, up from 15% last year; and 19% in the Desert, up from 18% last year).

There are several other indicators of county economic well being in this study which

cloud the picture slightly. Respondents offered perceptions about their own *personal* economic well being, and these were not necessarily consistent with their ratings of the county economy. Responding to the question "In comparison to a year ago, would you say that you and your family are better off, worse off, or the same," the vast majority of respondents in all four zones (79% or more) generally reported being either "the same" or "better off." Further, the percentage of respondents reporting being "better off" when compared with a year before has not changed significantly since the 2000 Annual Survey in all zones other than Victor Valley which saw a slight decrease (Table 15). Thus respondents' negativity regarding the economy in the county as a whole does not seem to extend to their evaluations of their own personal finances.

Further, the majority of respondents in three out of the four zones expect to be "better off" in terms of their family finances a year from now. Only Victor Valley respondents are slightly less optimistic about their future financial prospects, with only 47% expecting their finances to improve over the next year. An even more impressive display of optimism is that less than 4% of respondents in any zone anticipate being "worse off" than they are now. These findings are generally consistent with those in the last two reports.

Another indicator of personal economic well being is the question: "Thinking about your household income, would you say that it is *enough so that you can save money* or buy some extras, *just enough to meet your bills and obligations*, or *is it not* enough to meet your bills and obligations?" Many respondents reported having enough money to save and buy extras (Table 16). Yet, consistent with previous years' findings, a substantial number of people within all zones indicated that money was tight and that they had "just enough to pay their bills." In addition, a troubling number indicated that they don't have enough money to meet their bills and obligations (12 % in East Valley, 10% in West Valley, 16% in Victor Valley, and 15% in the

Desert). These figures do not differ significantly from past years. Still, there is a continuing polarization occurring between the 42% - 48% (depending on the zone) indicating that they have enough money to save and buy extras, vs. those who report being somewhat strapped for funds.

Finally, another indicator in the mixed picture about the economy is the fear about losing a job. Over 69% of the respondents in all zones express no concern whatsoever about losing their job. This is not significantly different than results from the 2000 survey.

In summary, then, there is a slight discrepancy between the way people rate the general economy of the county vs. how they respond to questions about their own personal economic well being. This may reflect what they believe about the world (via the news, particularly since the survey was conducted soon after the September 11 terrorist attack on the World Trade Center) vs. what they are actually experiencing in their everyday lives.

EVALUATIONS OF SELECTED PRIVATE AND PUBLIC SERVICES

OVERVIEW: Ratings of private and public services have not changed significantly overall in the county, with high marks continuing to be given to Police/Sheriff services, shopping, and parks/recreation services. On the other hand, street/road maintenance, entertainment, public schools and transportation continue to be problem areas.


Each year the Annual Survey includes questions regarding respondents' evaluations of local services from both the private and public sectors. Over time, there has been remarkable stability in rankings.



In previous years, police/sheriff services received the highest rankings overall in three out of the four zones, with the exception being West Valley in which it was rated second highest of all services. These findings are essentially replicated this year (Table 18). Comparing across regions, police/sheriff showed the highest level of "support" in the West Valley region.

The ratings of shopping improved in all zones (particularly in the East Valley area), and remain strong in all zones with the exception of the Desert area. In the West Valley, shopping continues to be rated the highest of all services evaluated in this study (as it has in past years).




Last year we reported that evaluations of public schools had declined since the previous year in all zones, with an especially sharp drop in West Valley ratings. This year saw some improvement in public opinion; however, the increase was quite small (and within the margin of error) in some zones. It is important to note that these less-than-stellar ratings are independent of



the respondents' income, ethnic origin, level of education, or presence of children currently in the home. As we've noted in previous reports, there are various interpretations/explanations of these

findings, which range from poor public relations by the schools, to negative reviews in the press, to a possible actual decrease in quality.

As has been the case in previous years, the evaluation of street and road maintenance is at or near the bottom of evaluations of all services. There was, however, a slight improvement in ratings in the West Valley (42% last year to 46 % this year) and a significant improvement in the Desert (22% last year to 28% this year). The situation is especially in need of improvement in the Victor Valley, where only 18% of respondents rated streets and roads as "excellent" or "good." Clearly this is an issue that has yet to be successfully addressed within the county.



Transportation is rated higher than streets and roads, however the ratings are much lower than those of many services. It must be pointed out that Victor Valley and Desert have seen significant improvements in ratings of the transportation options (an increase from 25% to 36% in Victor Valley, and from 30% to 40% in the Desert).

Ratings of area entertainment continue to be low.

LOCAL GOVERNMENT ISSUES

OVERVIEW: Most respondents report that newspapers are their major source of information about what local government is doing in their community. The majority of zone residents in all four zones are confident that their elected city officials will adopt policies that will benefit the general community. Ratings are slightly lower than last year's. On the other hand, a significant proportion of people within each of the four zones still expressed either "not much" or "no" confidence in their elected officials.

How do zone respondents get information about what their local government is doing in their community? Most (55% - 66%, depending on the zone) report that reading the newspaper provides them with their major source of information. There is a regional flavor to the preferred newspaper source: East Valley respondents tend to read *The Sun*, West Valley prefers the *Inland Valley Daily Bulletin*, Victor Valley respondents prefer the *Daily Press*, and Desert respondents report reading *The Sun* (although it is possible that some of the respondents meant *The Desert Sun* rather than *The Sun*). Television is a distant second as an information source (15% to 18%, depending on the zone).

Respondents were asked: "How much confidence do you have that the elected officials in your city will adopt policies that will benefit the general community?" A majority of respondents in all zones indicated that they are confident that their elected city officials will adopt policies that will benefit the community. On the other hand, there was an erosion in confidence since last year's report in three of four zones. Further, a significant proportion of people within each of the four zones expressed either "not much" or "no" confidence in their elected officials.
