- Fully-Online, Asynchronous Format
  Seven week sessions (2 per semester)
- Students can customize their program based on prior transfer credits (up to 70 previous semester units) and align their course of study with their professional goals
  - This allows students to focus on a smaller course load at one time while making adequate progress on their degree.



- Program Cost: \$475/semester unit
- The BAA Online Program accepts most type of Federal financial aid
- Students may pay remaining tuition in installments throughout the semester
- CSUSB's Veteran's Success Center can assist veteran students with maximizing their benefits eligibility for the BAA Online program.

### **Eligibility Requirements**

- 60 Semester (90 Quarter) units of transferrable coursework taken at a community college or regionally accredited university.
- Completion of lower-division general education requirements, including CSU History, Constitution, and American Ideals requirement. For more information, please visit the CSUSB Bulletin General Education Program.
- 2.0 Minimum Cumulative GPA
- Submit Application on Cal State Apply. The fee to apply to the CSU is \$70 per campus, per program.

## Prerequisite/Lower-Division Requirements

The Stater Bros. Market Online Degree Completion Program for the Bachelor of Arts in Administration in the Jack H. Brown College of Business and Public Administration requires students to be classified as an Upper-Division transfer student. This requires the completion of the requirements above.

Furthermore, students are highly encouraged to have completed all, or as many as possible, of the following lower-division degree requirements:

- ACCT 2110 Introductory Accounting I (3)
- ACCT 2120 Introductory Accounting II (3)
- ADMN 1500 Introduction to Administration (1)
- ADMN 2100 Applied Business Statistics (3)
- ECON 2201 Principles of Microeconomics (3)
- ECON 2202 Principles of Macroeconomics (3)
- IST 1110 Introduction to Information Technology (1)
- MGMT 2300 Legal Environment of Organizations (3)

- Three or four units chosen from the following courses:
  - MATH 1301 Modeling with Functions
  - MATH 1303 Stretch Modeling with Functions B
  - MATH 1401 Accelerated Preparation for Calculus
  - MATH 1403 Preparation for Calculus B
  - MATH 1601 Modeling with Calculus
  - MATH 2210 Calculus I

Students who have not completed the lower-division requirements above may still be admitted to the Online program, but will be required to complete them during their time in the program and prior to graduation.

Students are encouraged to research course transferability on Assist.org and consult with their Academic/ Transfer Counselor as soon as possible. Admitted students will be provided with a PAWS Report through their myCoyote Account which will highlight any deficiencies in their required courses.
