AVAILABILITY, LOCATION, AND METHODS TO SUMMON LAW ENFORCEMENT ASSISTANCE

Availability and Location of Law Enforcement Assistance

The California State University, San Bernardino Police Department (University Police Department “UPD”) is located at 5500 University Parkway, San Bernardino, CA and provides police services 24 hours a day to our community. Police Dispatch can be reached directly 24 hours a day by phone at (909) 537-5165 or (909) 537-7777.

Riverside Sheriff Department, Palm Desert Station, has primary jurisdiction for the safety and security of the Palm Desert Campus (PDC). Riverside Sheriff Department, Palm Desert Station, is located at 73705 Gerald Ford Drive, Palm Desert, CA and can be reached 24 hours a day at (760) 836-1600.

Enforcement and Arrest Authority

The police officers of CSU San Bernardino have state-wide police authority and jurisdiction per Penal Code section 830.2 and Education Code section 89560 and are vested with law enforcement powers and responsibilities identical to the local police or sheriff departments in your home community.

Crime Reporting

The entire campus community is strongly encouraged to report any and all known or suspected incidents of criminal activity on campus to UPD as soon as possible. When calling the University Police Department, always:

- Give your name, telephone number, and location;
- Give clear and accurate information;
- Be prepared to supply suspect and vehicle description, and direction of travel; and
- DON'T HANG UP! Follow the instructions of the dispatcher.

Students residing in on-campus housing may also report crimes to the on-duty Resident Advisor who will ensure the immediate notification to UPD.

Emergency Blue Light Call Stations

The 9-1-1 emergency telephone system will put you in contact with emergency personnel for any emergency or non-emergency need, 24-hours a day. There are over 60 emergency call stations located throughout the CSU San Bernardino campus, including residential housing, and five (5) at the Palm Desert Campus. There are over 500 surveillance cameras located throughout the two campuses, with over 440 on the San Bernardino campus and over 50 between PDC and the PDC Rec Center.

SPECIAL SAFEGUARDS FOR FACILITIES OR ACTIVITIES

Security of and Access to Campus Facilities

Most campus facilities are key-accessed, and most are open daily for scheduled campus community use. The Housing and Residential Education Buildings are accessible by card access only. Campus key control and distribution is a function of Facilities Services. To provide for the security of campus facilities, the University Police Department enforces Educational Code section 89031 & CSUSB Housing Policies. Campus facility access may be revoked per Penal Code section 626.

Security Considerations Used in Maintenance of Campus Facilities

Regular inspections and security surveys of campus indoor/outdoor lighting, shrubbery, and walkways are conducted. The University participates in Crime Prevention through Environmental Design concepts for planning and improvement on campus.

Special Event Safety Planning

Preparation for large events on campus involve the creation of Incident Action Plans according to the Standardized Emergency Management System and in collaboration with mutual aid agencies and contracted safety personnel.

ACTIONS IN THE LAST 18 MONTHS TO INCREASE SAFETY

- Traffic Calming project on North Campus Circle installed stop signs, speed feedback signs, pavement striping, and other traffic control signage to slow traffic and increase safety along that stretch of road.
- UPD launched a Bait Bike Program and an Unmanned Aircraft System (UAS) Program.
- Phones were upgraded in the Emergency Operations Center (EOC).
- Body Worn Camera technology was implemented for UPD officers.
- ADA modifications were made in Parking Lot G.
- Trees were removed and infrastructure reinforced by So Cal Edison to improve safety of power infrastructure and reduce Power Shutdown Events on campus.
- Emergency Management's Community Emergency Response Team (CERT) continued to be engaged, even during distance-learning and telecommuting.
- Precautions put in place across campus regarding COVID-19, including specific signage and directional flow in buildings to promote physical distancing and mask wearing. Provided Personal Protective Equipment (PPE) to campus. Outdoor furniture and shade structures were added to campus to promote safety during the pandemic. All restrooms are now equipped with touch-free fixtures to prevent disease transmission and all buildings are equipped with MERV-13 air filtration to prevent the spread of disease. Supported COVID Logistical needs regarding vaccinations and testing sites.

CHANGES IN SAFETY PRECAUTIONS DURING THE NEXT 24 MONTHS

- Campus Accessibility Improvements in Lot C and the sidewalk near Chaparral Hall to be completed over Winter Break 2021.
- Addition of Solar Panels and covered parking in Lot N to provide resiliency during power outages.
- Environmental Health & Safety to create an employee safety-training program that will include preparedness and emergency procedures portion.
- Training with Community Emergency Response Team (CERT); executing "The Great Shake Out" and Tabletop EOC Exercises for both campuses.
- Risk Management will complete Job Hazard analyses for all job classifications on campus.

RECORDS OF ON-CAMPUS CRIME

California Education Code 67380(a)(1)(A)

California State University campuses are required by California Education Code 67380(a)(1)(A) to compile records of all occurrences reported to campus police, campus security personnel, or campus safety authorities of, and arrests for, crimes that are committed on campus and that involve violence, hate violence, theft, destruction of property, illegal drugs, or alcohol intoxication, and to make this information available within two business days if requested by students, prospective students, employees, or the media.
