The Nutrition and Foodservice Professional Online Training Program requires 150 hours of field experience in a healthcare facility to learn the practical application and management of dietary services.

The CSUSB College of Extended and Global Education tuition payment includes the Registered Dietitian Preceptor oversight needed to complete the course as assignments are submitted online to the Online Registered Dietitian Preceptor. This relieves the healthcare facility of the expense of student management while also ensuring a high-quality educational program with consistent standards for field experience.

The Online Dietitian Preceptor is responsible for the 150 hours of field experience and supervising the nutrition-related hours. Each field experience student is precepted by a qualified preceptor with no less than one year of post-registration/certification, full-time equivalent employment in a practitioner role.
