<b>Stalking</b>	Student	Student reported another student was stalking him. A no-contact order was issued, and the Respondent was required to meet with a Case Manager to discuss boundaries and communication skills.
<b>Sexual Misconduct</b>	Student	No Contact Order after student reported another student had touched her hair and face
<b>Sexual Misconduct</b>	Student	Student reported she rescinded consent while another student was kissing her. A no-contact order was issued.

Description of Outcomes for incidents with no investigation		
<b>Stalking</b>	Non-Affiliate	Student reported an ex-boyfriend was stalking her. Resources were given to student. Student only wanted to pursue academic remedies.
<b>Sexual Misconduct</b>	Non-Affiliate	Student only requested resources for academic remedies due to psychological trauma from past sexual misconduct with non-affiliate.
<b>Dating Violence</b>	Non-Affiliate	Student reported dating violence from ex-boyfriend, resulting in police report and TRO. Student wanted assistance with a retroactive withdrawal.
<b>Sexual Misconduct</b>	Unknown	Student reported a sexual misconduct with an unknown party. Student was linked with CSUSB Advocate and Counseling Services. A housing change was offered and accepted. Student declined police report.
<b>Sexual Misconduct</b>	Non-Affiliate	Student reported a sexual misconduct with a non-affiliated person. Student linked with CSUSB Advocate during intake. Student requested assistance with re-enrolling.
<b>Dating Violence</b>	Non-Affiliate	Student reported past dating violence with a non-affiliated person. Student linked with CSUSB Advocate, who assisted her in filing a police report. Student only requested assistance with academic accommodations.

<b>Dating Violence</b>	Non-Affiliate	Received report from UPD regarding a dating violence involving a non-affiliate threatening a student with a weapon. Student was given resources and options, but still remained in the relationship. Student was linked to the CSUSB Advocate for assistance.
<b>Domestic Violence</b>	Non-Affiliate	UPD responded to a domestic violence incident involving a non-affiliate and a student. Student met with CSUSB Advocate, and received a Temporary Restraining Order. Student also connected to Counseling.
<b>Dating Violence</b>	Non-Affiliate	UPD responded to a dating violence with a non-affiliate and student. Student did not respond to our attempts to assist her with any interventions. Referrals were offered.
<b>Sexual Misconduct</b>	Student	Student reported a sexual misconduct by an unknown classmate who touched her buttocks. After an investigation into her class schedule, it was determined that no one by the first name given to Title IX was enrolled in her class. There was no further information available to name the respondent. Student was linked to CSUSB Advocate for further assistance.
<b>Stalking</b>	Non-Affiliate	Student reported a former partner was appearing at the student's residence hall. Student did not feel fearful, but was given resources and linked to CSUSB Advocate.
<b>Sexual Misconduct</b>	Non-Affiliate	Title IX was made aware of a student who had reported a sexual assault that occurred off campus in 2012. Student had already sought resources, and declined any accommodations. Student was linked to CSUSB Advocate.
<b>Sexual Misconduct</b>	Non-Affiliate	Student stated she was sexually assaulted off campus by a non-affiliate. Student sent to the hospital for a VAWA exam, and linked with both on campus and off-campus advocates.
<b>Sexual Misconduct</b>	Non-Affiliate	Student reported a sexual assault that occurred in another country with a non-affiliate. Student wanted support and resources. Student linked to CSUSB Advocate.

<b>Stalking</b>	Non-Affiliate	Student reported a non-affiliate had called numerous times and was seen on campus. Title IX assisted with filing a police report, and student reported feeling safe without any further accommodations.
<b>Sexual Misconduct</b>	Non-Affiliate	Staff member reported being sexually assaulted off campus by a non-affiliate. The staff person was linked to CSUSB Advocate and other off-campus support resources.
<b>Sexual Misconduct</b>	Non-Affiliate	Student disclosed a past sexual assault to an administrator. Academic and Housing remedies were offered.
<b>Stalking</b>	Non-Affiliate	Staff member reported stalking from a former student, who had signed an informal agreement in 2014. T9 sent a reminder of the agreement and gave the staff member resources to avoid further contact.
<b>Stalking</b>	Non-Affiliate	Student reported a non-affiliate living in another state was stalking her. T9 connected the student with UPD to file a police report. Student declined other safety planning precautions.
<b>Sexual Misconduct</b>	Non-Affiliate	Sexual assault of a student by a non-affiliate off campus. Student filed a police report, and was linked with the CSUSB Advocate.
<b>Domestic Violence</b>	Non-Affiliate	Staff person reported domestic violence at her off-campus residence. Staff person was linked with CSUSB Advocate and Human Resources.
<b>Stalking</b>	Non-Affiliate	Student reported an ex-boyfriend was stalking her. Title IX assisted the student in filing a report with the police.
<b>Dating Violence</b>	Unknown	Student reported having an abusive relationship with an unknown student. Requested to meet with the CSUSB Advocate. Declined to give further information or to have any further assistance.
<b>Sexual Misconduct</b>	Unknown	Student reported a sexual battery that took place with an unknown person off campus. Title IX assisted student in filing a police report.
<b>Dating Violence</b>	Non-Affiliate	Professor reported seeing visible marks on a student due to dating violence. Title IX reached out to the student on multiple occasions to offer resources, but the student did not respond.
<b>Sexual Misconduct</b>	Student	Complainant given resources. Respondent passed away before the incident could be investigated.

Descriptions for Investigations with Insufficient Evidence		
<b>Sexual Misconduct</b>	Student	Student claimed she did not consent to a kiss, as well as her thigh being touched by Respondent. Insufficient evidence.
<b>Sexual Misconduct</b>	Student	Student claimed she did not consent to sexual activity due to incapacitation. Insufficient evidence.
<b>Stalking</b>	Students (3)	Student claimed three students were stalking her on campus. Insufficient evidence.
<b>Dating Violence</b>	Student	Title IX received a report of dating violence. There was insufficient evidence from both parties to conclude that dating violence had occurred.
<b>Sexual Misconduct (pending beginning)</b>	Student	Student claimed she agreed to certain sexual activities but not others. There was insufficient evidence to find a violation.
