Unfortunately, IEFLA is not planning to hold an in-person Honors Reception at this time.

We currently have \$8998.43 in CASLA funds (\$3860.79 in Philanthropic Gift Fund, P2140-P204407 and \$5137.64 in State Trust Fund, SF014). We now realize that we reported the balance for last year incorrectly (as \$6714.78), when in reality the combined balance was \$8998.43. We do not plan to solicit external/internal funds. We plan to spend down our budget next year and the following if needed.
