As of June 30, 2021, \$26,243,650 of Emergency Financial Aid Grants has been distributed to students under the CRRSAA and ARP (a)(1) and (a)(4) programs.

For the Quarter ending June 30, 2021, the total number of students who have received an Emergency Financial Aid Grant to students under the CRRSAA and ARP (a)(1) and (a)(4) programs were 46.

**The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA and ARP (a)(1) and (a)(4) programs.**

Per guidance from the US Department of Education, CSUSB utilized Free Application for Federal Student Aid (FAFSA) and the California Dream Act Application (CADAA) data on "Unmet Need" (the estimated cost of attendance minus a student's reported access to financial resource, per their FAFSA and CADAA) to determine student eligibility. These grants ranged between \$210 and \$895, based on the student's financial need and the number of units the student was enrolled in the applicable semester. Additionally, to be eligible for the HEERF Emergency Fund program, students must have met the following requirements:
