# BRAD Award Brings Campus Granting Resources

Dr. Bryan Haddock's recently awarded National Institutes of Health (NIH) Biomedical / Biobehavioral Research Administrator Development (BRAD) grant offers new opportunities

campus-wide for faculty researchers and research administrators.

"The BRAD grant is designed to help faculty perform biomedical and biobehavioral research" Haddock explains. The goals of the 3-year project,

"Improving Practices for Biomedical and Biobehavioral Research Administration," include but are not limited to improving customer service in both pre- and post-award functions, improving effectiveness of faculty grant writing, and providing more accessible and more efficient opportunities to

complete compliance training.

The first grant-funded activity offered for faculty was a grant writing workshop completed this past June. Provided by

Grant Writers' Seminars and Workshops, LLC (GWSW), the one-day seminar was offered on campus in the Phau Library and available via video-streaming to six other interested CSU campuses (Bakersfield, Fresno, Humboldt State, Monterey Bay, San

Marcos and Sacramento).

Very well received, the workshop provided over 130 grant writing participants with strategic insider tips, helpful handouts and a step-by-step workbook to use as a guide when writing a proposal. *Continued*, *p.2...*

Some workshop participants commented, "The mysteries of federal agencies' requirements and reviewers' expectations have been diminished", "The book is the best resource I have seen for grant writing!" and "Wonderful workshop, even to someone who thought they "knew" – I didn't! Thank you!" If you missed the first workshop, a similar grant-writing workshop will again be offered in the Spring/Summer 2014 and 2015.

Here is a look at some additional research activities and

resources BRAD funding will provide over the next three years of the project:

Step-by-Step **Assistance:** Haddock encourages faculty to contact him directly for assistance strategizing and/or writing a proposal. "I'll work with people individually or sometimes in small groups to help them work through a step-by-

> step process on how to get the grant written," he explains.

This step-by-step process can include finding grant opportunities (at NIH or other appropriate agencies/ foundations) as well as writing the final grant submission. Haddock has found it helpful to break down the grant into small sections and address each agency -required component one area at a time, until all sections are concisely written, thoroughly edited and polished for agency submission.

Pre-Proposal Review: Haddock explains this grant-writing process may also include sending a completed draft of your proposal to an external reviewer for feedback prior to submitting it to the agency for funding. "They will give comments as if they were on a panel reviewing the grant," he states. For example, NIH now allows only one submission and one revision per proposal to address reviewers' comments when past regulations allowed for up to two revisions. This "extra" external review now funded by the BRAD grant can provide faculty an invaluable opportunity to address comments from someone familiar with the agency preferences and standard review processes, prior to making a formal submission.

**Collaborators:** Haddock can help faculty connect with collaborators. This may be necessary early in the proposal development process for some, as Haddock describes "Some faculty members haven't done anything with stats since graduating; so we can utilize a statistician in the writing process to help build the grant." In addition, if faculty have an area they want to research and need somebody with a different area of expertise, Haddock states, "We'll help them find people to connect with and collaborate with, either people from Cal State or from

other universities or community colleges." **Strengthening Resources:** As part of the BRAD grant, representatives of the Office of Sponsored Programs (pre-award) and Sponsored Programs Administration (post-award) will obtain immersive training in submission activities and grants management to help provide consistent, expert customer service to faculty. These training opportunities will strengthen our current resources and better prepare research administrators by providing insight about agency specific policies and procedures, thereby improving efficiency in the pre-and-post award processes. **Informational Sessions:** Throughout the course of this project, Haddock plans to coordinate meetings between interested faculty members and key departments on campus. These informational sessions will help researchers to share information about their projects and operations with appropriate departments such as Financial Aid, Human Recourses, Facilities, SMSU, etc. Meetings will highlight policies and procedures, ensuring we are creating grants and managing funds, most efficiently. Haddock explains, "We'll ask questions like, how will that impact the grant? And address issues such as stipends versus payroll? Are there alternatives? What's most efficient?" Web-based Compliance Training: BRAD funding will provide an efficient way for researchers to obtain training and assurances in Human Subjects, Research

Ethics/Responsible Conduct of Research (RCR), Financial Conflicts of Interest (FCOI) and other requirements online. Using a centralized web-based system, provided by CITI (Collaborative Institutional Training Initiative, will allow required training to fit into faculty's busy schedules (available online 24 hours a day – 7 days a week) and permits Academic Research the ability to efficiently monitor training compliance. ...continued page 21

SPOTLIGHT: Diane Podolske's project, "PASS GO" is funded by the Title V HSI STEM grant program. The purpose of the PASS GO program is to develop articulation agreements and a pipeline program between San Bernardino Valley College (SBVC) and California State University, San Bernardino (CSUSB) to increase the number of Hispanic and other low income students, to attain degrees in the science, technology, engineering, or math (STEM) disciplines.



Cost Sharing

# Did you know...?

Cost Sharing is defined as any project costs that are not funded by the sponsoring agency.

**Mandatory Cost Sharing:** It may be required by the funding agency as a condition of the award and therefore is referred to as mandatory cost sharing. Ordinarily, this requirement will be listed in the program announcement or the request for proposal (RFP). When mandatory cost sharing is included in an award, it will be listed in the Notice of Grant/ Contract Award.

**Voluntary Cost Sharing:** When cost sharing is not required by the funding agency, but offered in the proposal, it is considered voluntary cost sharing.

Cost sharing that is proposed voluntarily becomes mandatory once the award is made and will be tracked and documented by UEC at CSUSB, in conjunction with the Project Director.

Cost sharing commitments must be expressed in terms

that can be readily translated into absolute dollar amounts (e.g. faculty salaries and fringe benefits, travel, equipment, supplies, or reduced indirect costs).

All cost sharing commitments must be approved by the University Provost, College Dean, and the department head that will be supplying the cost sharing, before a proposal is submitted to a granting agency. When the Dean signs the Project Information Form and if there is any kind of cost sharing from the college on that form, he/she is committing to those costs.

**Terms used to refer to Cost Sharing:** Contributed, Matching, In-kind, Non-Federal funds, Cash, Assigned Time

**Tracking:** All documentation on cost sharing is subject to audit in accordance with the funding agency policies. All commitments whether mandatory or voluntary must be tracked and certified in order to remain in compliance with funding agency and auditory requirements.



Additional Course Release: Once your proposal obtains funding, the BRAD project may commit to support an additional course release for NIH funded research projects. In other words, should your NIH research proposal be funded, BRAD support will "buy out" an additional course release or provide summer salary for you to help you complete your research. This may be a competitive process, depending upon the amount of funded applicants. A long-term goal of the project is to have CSUSB institutionalize this course matching policy for future funded NIH projects.

Haddock, involved with helping faculty in the granting process for well over a decade, experienced immersive training at USDA in 2002, thanks to a grant funding his own research. From there things evolved when Sponsored Programs requested he become Project Director of what was to become the very successful CSUSB Extramural Associates Research Development Award (EARDA) grant from 2006-2011. Haddock obtained agency-specific training from NIH and NSF among others and was even invited to sit in on some formal review panels to gain an insider perspective of the process. He is very familiar with the regulations and preferences of numerous federal agencies and knowledgeable of the campus policy and procedures involved in extramural research.

Haddock shares that over the project period EARDA helped to establish a campus research infrastructure that will now be improved upon and expanded with funds from the BRAD award. "I just kind of fell into it," he acknowledges, and finds that helping faculty achieve their research goals now takes up most of his personal



research time, but he loves it; being able to help faculty navigate the intimidating process of grant submission and obtain funding is beyond rewarding.

# News from NSF

National Science Foundation Changes to Note in the January 2013 Grant Proposal Guide

#### Proposal Preparation & Submission:

The **Project Summary** has been revised to omit language regarding the inclusion of separate headings to address the two merit review criteria. FastLane has now been modified to display three separate text boxes in which proposers must provide an

Overview and address the "Intellectual Merit' and "Broader Impacts" of the proposed activity. The text boxes have a character count function limiting the entire summary to 4600 characters. Please note that the template does not support any special formatting or font.



The **Project Description** must now contain, as a separate section within the narrative, a discussion of the broader impacts of the proposed activities. In addition, **Results from Prior NSF Support** was updated to indicate that Intellectual Merit and Broader Impact activities must be described in two separate sections in the summary of Results from Prior NSF Support. **Biographical Sketch(es)** has been revised to rename the "Publications" section to "Products" and amend terminology and instructions accordingly. This change makes clear that products may include, but are not limited to, publications, data sets, software, patents, and copyrights.

Facilities, Equipment and Other Resources has been supplemented to indicate that an aggregated description of the internal and external resources that are, or will be available to the project (both physical and personnel) should be provided. This is the place that any voluntary contributions to the project (e.g., and additional course release provided by the College) is discussed, rather than in the Budget Justification. This change was made to comply with the NSF cost sharing policy which prohibits contributed match on virtually all their awards.

#### **Proposal Review:**

NSF Proposal Processing and Review has been revised to insert language to reiterate the importance of integration of research and education and broadening participation as core strategies, as outlined in NSF's strategic plan.

#### **Award Reporting:**

"Welcome to Research.gov!" Research.gov is the National Science Foundation's (NSF) grants management system that provides easy access to research-related information and grants management services in one location. Research.gov is the modernization of FastLane, providing the next generation of grants management capabilities for the research community. All award reporting (annual and final project reports) is now conducted through the Research.gov portal. Your Fastlane log-in information remains the same within Research.gov. If you have not yet done your first reporting through Research.gov, give yourself a bit of additional time to familiarize yourself, as the interface is very different than FastLane.



## FUNDING AGENCY Helpful Hints

Research what gets funded; find the angle that the agency leans toward funding and go that way! Check grant databases to review existing grants that have already been successful in obtaining funding.

- E-mail the funding agency program director and state that you want to "maximize programmatic relevance." Some are willing to provide feedback prior to your submittal. Some funding agencies (e.g. NEH) even encourage this contact to aid in your success.
- Read funding agencies, mission statements carefully. Include those missions to make your proposal more persuasive. Show how your proposal aids the agency in achieving its overall goals.
- Tell reviewers why your proposal is important to the future of your field. Remember, reviewers cannot be experts in every field of study. Without talking down to them, point to key benefits and how your work could have an amplified impact in your field.
- Paraphrase. Do not repeat. Clever repetition works to convey your point, but double talk can be off-putting.
