I suppose it is always time for that....BUT for this year, now is time for everyone to fill out their Financial Aid applicationsloans, grants and scholarships.

Go to the <u>Financial Aid website</u> and click through the links. File your FAFSA and apply for Scholarships. If you don't fill out the FAFSA form, you could be missing out on a lot of financial aid! Note there is a universal scholarship application, separate from the FAFSA. You can call Financial Aid for assistance or attend workshops on the forms. The application deadline is March 2nd.

Besides the loans and scholarships on the Financial Aid pages, there are a variety of programs offered through Graduate Studies. Note the Graduate Equity Fellowship which requires a separate application. There is also money available to help students attend conferences. Keep this in mind.

Congratulations to Tyler Morris-Seekins (MPA 2016) on his career advancement.

"When I graduated with my MPA, I was an EEO analyst working for the State of California at the Department of Resources, Recycling, and Recovery (CalRecycle). Since then, I was able to have been promoted twice, once in Dec. 2016 to an EEO Manager (Staff Services Manager I) role and then again in August 2018 to my current role as the Administrative Services Manager (Staff Services Manager II) for the California Earthquake Authority (16+ billion earthquake insurance company/quasi-governmental agency).

In my current role, I manage, supervise, and lead a team of seven (in what seems) almost all major aspects of public administration ranging from human resources, business services, facilities, training, health and safety, equal employment opportunity, procurement, etc. I believe the MPA degree was something that played a significant role in my ability to get these promotions/new jobs and is something that solidifies my knowledge, skills, abilities to succeed in a public administration setting."
