 consider expanding these spaces. Still need for faculty research.
 - Anthony Creativity with outdoor space. Mobile services/kiosks across campus.

 - Eric If more hybrid courses (especially large lectures), less need for lecture hall space, but still need space for students to take online classes. Informal instructional gathering spaces/lounge spaces. Alison – flexible collaborative spaces have been popular in office environments, but education more resistant to this; no clear function.
 - Anthony some students take online classes in their cars with cars running for a/c (consider carbon footprint).
 - CFA contract states tenured faculty must have an office, prescribed space allotted for students. Outdated matrix for entire CSU campus.
