## **JAILS AND CORRECTIONS**

Know Your Rights, You Never Know If You Will Be Detained And Later Found Innocent.

If you are detained for evaluation by the Courts for a possible conviction and punishment, and you are on hormones there are a few things that it is imperative that you know:

1. You have an absolute 'right' to be safe from violence and sexual assault while detained.

- 2. Under the new PREA cited above, Transgender Persons receive unique treatment during strip searches, cavity searches and showering. Failure to do so is a violation of PREA and considered sexual harassment. Federal PREA Mandate on the County: §115.15 Limits to Cross-Gender viewing and searches, (f), "The agency shall train security staff in how to conduct cross-gender pat-down searches, and searches of transgender and intersex inmates, in a professional and respectful manner, and in the least intrusive manner possible, consistent with security needs." § 115.42 Use of screening information, (f), "Transgender and intersex inmates shall be given the opportunity to shower separately from other inmates." As of the date of this document, Riverside County Jail does not comply with these mandates and have not made them a top priority, as the law requires.
- 3. If you have had your gender legally changed, it is very important that they do not list you as the housing gender. The reason for this is that the Jails processing unit that cannot see you can determine that you are a particularly vulnerable inmate by the opposite gender documented in the control units listings. Farmer v. Brennan (1994) 511 U.S. 825.
- 4. During medical intake, it is 'imperative' that you inform medical that you are transgender, on medications, Hormone Replacement Therapy and your doctor's name and location so they can continue your medications. Double check multiple times during the medical intake to make sure they have documented you as transgender and you are on hormones. http://www.transgenderlaw.org/resources/prisoners.htm

# **NAME/GENDER CHANGES**

The process for name changes has changed:

Generally, to get a court order changing your name and gender, follow these steps.

- 1. Fill out your court forms.
- a. Petition for Change of Name and Gender (Form NCC-200) and attachments to Petition for Change of Name (Form NC-100);
- b. Order to Show Cause for Change of Name (Form NC-220); and
- c. Civil Case Cover Sheet (Form CM-010).

2. Have your doctor fill out an affidavit telling the court that you have undergone clinically appropriate treatment for change of gender.

Your doctor can use the Declaration of Physician—Attachment to Petition (Form NC-210) or write out his or her own declaration. It is very important a licensed physician do it, a nurse cannot do it. If your doctor uses his or her own letter, make sure it contains the required information.

- 3. Have your forms reviewed
- 4. Make copies of all your forms. You will need 1 copy of all your forms except for Form NC-220. You will need 2 copies of NC-220.
- 5. File your forms with the court clerk

File all the forms in the superior court in the county where you live. The clerk will stamp your forms "Filed", keep the original, and return the copies to you. The clerk will give you a date for your court hearing and will write it on the Order to Show Cause, along with information on the time and department number for your hearing. You will have to pay a filing fee of \$435.00 or you can file a fee waiver form if you are low to no income. (Form FW-001)

#### 6. Publish the Order to Show Cause

Publish the Order to Show Cause for Change of Name in a newspaper of general circulation once a week for 4 weeks in a row. Your court most likely has a list of newspapers that are approved for publishing legal notices. The cost for publication can vary greatly between newspapers and your court fee waiver will not waive your publication fees. So it is very important that you check the price of publishing BEFORE you put the name of the newspaper in the Order to Show Cause for Change of Name (Form NC-220). This is because once the judge signs the Order to Show Cause for Change of Name, you must publish in the newspaper list on the form. You cannot change the form after it is signed. The procedures for publishing in a newspaper have changed for Transgender persons that qualify: http://www.eqca.org/atf/cf/%7B34f258b3-8482-4943-91cb-08c4b0246a88%7D/AB-1121.PDF

#### 7. Go to Court hearing

Go to court on your court date and take your proof that the Order to Show Cause was published in the newspaper, along with the Decree Changing Name and Gender (Form NC-230) for the judge to sign.

8. Get your Decree Changing Name and Gender from the court

If the judge approves your request for change of name and gender, the judge will sign the Decree Changing Name and Gender (Form NC-230) Once you get your signed decree, get a certified copy from the court clerk. You will need this to change all your legal documents, including your birth certificate and other government-issued identification like your driver's license.

Department of Corrections Name Changes:

- 1. The Inmate or parolee must first be granted permission by the Warden or Parole Office. Title 15\s 3294.5 Inmate Name Change.
- 2. If the Inmate or Parolee is denied the name change they must first properly exhaust the inmate grievance process.
- 3. If it is not granted at the Director Level Review the inmate must petition the Court to be granted the name change.
- 4. If the Court denied the inmate must appeal up the levels of Court until relief is granted, if it is granted then the inmate will start the process the same as a citizen would above.

# **GENDER CHANGES**

- 1. Fill out your court forms:
- a. Petition for Change of Gender and Issuance of New Birth Certificate (Form NC-300)
- b. Setting of Hearing on the Petition for Change of Gender and Issuance of New Birth Certificate (Form NC-320); and
- c. Civil Case Cover Sheet (Form CM-010)
- 2. Have your doctor fill out an affidavit telling the court that you have undergone clinically appropriate treatment for change of gender. Your doctor can use the Declaration of Physician—Attachment to Petition (Form NC-310) or write out his or her own declaration. It is very important a licensed physician do it; a nurse cannot do it. If your doctor uses his or her own letter, make sure it contains all the required information.
- 3. Have your forms reviewed.
- 4. Make at least 1 copy of all forms.
- 5. File your forms with the court clerk.

File all the forms and copies in any superior court. The clerk will stamp your forms "Filed," keep the original and return the copies to you. The clerk will give you a date for your court hearing and will write it on the Setting of Hearing on the Petition for Change of Gender, along with information on the time and department number for your hearing. You will have to pay a filing fee. The filing fee is \$435.00. If you are low income to no income there is a fee waiver form that you can provide the court clerk. (Form FW-001)

6. Go to your court hearing.

Go to Court on your court date. Take the Order for Change of Gender and Issuance of New Birth Certificate (Form NC-330) for the judge to sign.

7. Get your Order for Change of Gender from the Court.

If the judge approves your request for a change of gender, the judge will sign the Order for Change of Gender and Issuance of New Birth Certificate (Form NC-330). Once you get your signed order, get a certified copy from the court clerk. You will need this to

change all your legal documents, including your birth certificate and other government-issued identification like your driver's license.

# **HORMONE THERAPY:**

V.A. Hormone Therapy

#### PROCESS:

- 1. Become familiar with your insurance plans, this will determine the course you can take with which doctor. As an example: Dr. Del Rosario does not take Medi-Cal or I.E.H.P., on its own, but takes Medicare paired with Medi-Cal or I.E.H.P., as the secondary.
- 2. You must First Qualify. Not all Veterans Qualify.
- 3. Contact and you will be seen by the Head of the Women's Clinic or the psychologist at the women's clinic.
- 4. They will tell you-you need a release for from your primary doctor before treatment to HRT.
- 5. Then you have blood tests.
- 6. Then you meet with the transgender health care staff.
- 7. Be prepared to go to all sorts of specialists to complete the process, including blood work, endocrinologists, and etc.
- 8. Be patient it takes time.

Medi-Cal, Medi-Care and I.E.H.P. Hormone Therapy

#### PROCESS:

- 1. Become familiar with your insurance plans, this will determine the course you can take with which doctor. As an example: Dr. Del Rosario does not take Medi-Cal or I.E.H.P., on its own, but takes Medicare paired with Medi-Cal or I.E.H.P., as the secondary.
- 2. First you must go to a Psychologist that is covered by your insurance and get diagnosed with Gender Identity Disorder. There is a list of Psychologists in this resource.

- 3. Set up your appointment with one of the listed doctors.
- 4. The doctor will evaluate you and determine your course of treatment.
- 5. Be prepared to go to all sorts of specialists to complete the process, including blood work, endocrinologists, and etc.

Private Insurance Hormone Therapy

#### PROCESS:

- 1. First you must go to a Psychologist that will diagnose you with Gender Identity Disorder. There is a list of Psychologists in this resource.
- 2. Set up your appointment with one of the listed doctors.
- 3. The doctor will evaluate you and determine your course of treatment.
- 4. Be prepared to go to all sorts of specialists to complete the process, including blood work, endocrinologists, and etc.

# **GENDER REASSIGNMENT SURGERY:**

Medi-Cal, Medi-Care and I.E.H.P. Gender Reassignment Therapy

Covered Medi-Cal benefits include:

- 1. Psychotherapy
- 2. Continuous hormonal therapy
- 3. Laboratory testing to monitor hormone therapy, and
- 4. Gender reassignment surgery that is not cosmetic in nature

Gender reassignment surgery is covered when the individual with GID is at least 18 years of age, has the capacity for fully informed consent, and the WPATH criteria for the surgery have been met. Covered benefits include mastectomy, orchiectomy, hysterectomy, salpingooophorectomy, ovariectomy and genital surgery, including placement of testicular prostheseswhen indicated.

Augmentation mammoplasty for male-to-female individuals (MtF) is a covered benefit only when an appropriate trial of hormone therapy has not resulted in breast enlargement.

Intersex surgery should not be requested or billed using CPT-4 code 55970 (intersex surgery; male to female) or CPT-4 code 55980 (intersex surgery; female to male). Due to the serial nature of surgery for the gender transition, CPT-4 coding should be specific for the procedures performed during each operation. A Treatment Authorization Request (TAR) is necessary only for procedures that currently require a TAR.

Non-Covered Benefits

The following surgeries are considered cosmetic in nature and are not covered Medi-Cal benefits:

- 1. Reduction thyroid chondroplasty
- 2. Rhinoplasty
- 3. Facial bone reconstruction
- 4. Face lift, blepharoplasty
- 5. Voice modification surgery
- 6. Hair removal or transplant, and
- 7. Liposuction

Augmentation mammoplasty is not a covered benefit for MtF individuals except as noted above.

Private Insurance Gender Reassignment Surgery

1. It would be the same process for Medi-Cal, I.E.H.P., and Medi-Care and with your private contracted providers through your private insurance. It will most likely require a grievance to receive this right through your insurance provider.

We now have a much larger shelter, a transitional housing program, a separate outreach office, satellite offices in the cities of San Bernardino and Fontana, and we have embarked on several new programs: two runaway/homeless youth shelters, a homeless youth street outreach team, youth drop-in centers, Next Step re-entry program, community centers, antihuman trafficking program, and other programs and services to support the needs of our Victor Valley, San Bernardino, and Morongo Basin communities.

As the community needs have been identified, the agency has grown to accommodate and assist our population.

We provide assistance with restraining orders, advocacy, homelessness, homeless prevention, rapid re-housing, preventative services through teen violence classes, substance use disorder classes, family/group/individual counseling, supervised

visitation, and the distribution of household commodities are just some of the services we provide to our community in need.

It is our goal and continued effort to build stronger families through other services that do not necessarily pertain only to Domestic Violence. Our agency is growing more diversified as the community develops and the needs are assessed. In turn, all these services have been offered in an effort to assist low-income families in creating safe and stable homes.

  - Good basic introduction and overview of early asexual research. As it was published in 2012, the research summaries are becoming out of date both the quantity and quality of asexual research has been trending upward at a rapid rate since 2013. However, it still serves as an accessible introduction to the field for those who have no idea where to start.

- Very much an outside researcher perspective; sometimes a bit out of touch with the lived experiences of actual asexuals (especially in chapters 11 and 12, which I recommend skipping).
- Of particular interest is chapter 9, "Do you have hypoactive skydiving disorder".
- Asexuality: The Invisible Orientation by Julie Sondra Decker (aka Swanklvy)
  - Ace community perspective, from an experienced ace community member. Lots of personal anecdotes about the actual lived experiences of ace people.
