On the other hand, the EQIP program is a voluntary conservation program administered by NRCS that can provide financial and technical assistance to install conservation practices that address natural concerns. The purpose of EQIP is to promote agricultural production, forest management, and environmental quality as compatible goal; to optimize environmental benefits and to help farmers and ranchers meet Federal, State, Tribal and local environmental regulations. I learn how to fill and administer all the forms required for farmers to get assistance for their land. I also attended district meetings which allowed me to know what our community needs. This was really interesting for me because it's one of my fields of studies. I also made field visits where I learn how agronomy and the field business work. Most importantly, I had the opportunity to write two articles for NRCS. I wrote one article for California e-Flash Newsletter and for the Quechan Indian Tribe.
