University Police Standard Operating Procedure (SOP)

Timely Warnings

I. Purpose:

This SOP establishes the University Police Department (UPD) procedure for the assessment, production and dissemination of Timely Warnings, consistent with the Jeanne Clery Act, CSU Executive Order 1107 and UPD Policy 808.

II. Definition(s):

Timely Warning: A warning delivered to the CSUSB campus community regarding a reported Clery crime, within the Clery geography. The warning must be delivered as soon as practical after a Clery crime is reported. The warning must provide enough information to support crime prevention and safety related decision making.

III. Employee Responsibilities:

The Primary Officer assigned to investigate a Clery crime shall perform an assessment of the need for a Timely Warning. The primary officer may delegate the associated tasks, but not the responsibility.

IV. Supervisor Responsibilities:

The On-Duty supervisor or the Officer-in-Charge shall ensure Timely Warning assessments are completed for all reported Clery crimes and that Timely Warnings are sent in a manner consistent with the spirit of the Jeanne Clery Act.

The UPD Clery Coordinator shall retain copies of all Timely Warnings consistent with the approved CSU Records Retention Schedule.

The UPD Clery Coordinator shall conduct a monthly reconciliation of Timely Warning Assessment Forms and reported Clery crimes. The Clery Coordinator shall work with the UPD Lieutenant and Supervisors to ensure an assessment form exists for every Clery crime incident. The reconciliation record shall be retained with the Timely Warning Assessment Forms.

V. Timely Warning Assessment Procedure:

- Primary Officers assigned to investigate a Clery crime shall, during the preliminary stages of the investigation and prior to closing the call, assess the need for a Timely Warning to the Campus community.
 - a. The officer's assessment shall be recorded on the Timely Warning Assessment form (see attached form).
 - b. The officer's assessment shall consider the totality of the circumstances including historical and indirectly-related information.
- 2. The Officer's assessment shall answer the following three questions: 1) Was a Clery crime reported? 2) Did the Clery crime occur within the University Clery Geography? 3) Does the Clery crime represent a serious or ongoing threat to the campus community?
 - a. Consult the attached maps for Clery Geography boundaries.
 - b. Generally, crimes listed in California Penal Code sections 1192.7 or 1192.8 shall be considered serious, unless mitigated by other circumstances. A Clery crime could be considered serious even though it is not listed in Penal Code section 1192.7 or 1192.8.
 - c. <u>No Timely Warning shall be issued unless all three assessment questions listed above are answered in the affirmative.</u>

- d. In cases where a Timely Warning is not issued, it may be prudent to send an "Information" or "Crime" Bulletin to the campus community. However, such a Bulletin <u>shall not</u> be titled "Timely Warning".
- e. The Officer shall present the completed assessment form to an on-duty Sergeant for review prior to the end of the shift.
- f. The Sergeant shall submit the completed and reviewed assessment form to the Lieutenant prior to the end of the shift.
- g. The Lieutenant shall finalize the form and submit it to the Clery Coordinator for final review and filing in support of an audit.

VI. Timely Warning Notification Procedure:

- 1. When all three assessment questions are answered in the affirmative, the primary officer shall immediately notify the On-Duty Sergeant or Officer-in-Charge.
- 2. The On-Duty Sergeant or Officer-in-Charge shall immediately notify the On-Duty or On-Call Lieutenant.
- 3. The Primary Officer shall, as soon as practical, draft a Timely Warning and email it to the On-Call Lieutenant for review.
 - a. The draft Timely Warning shall be completed consistent with the attached format and the embedded instructions.
 - b. All Timely Warnings shall include three "Safety Reminders" to aid the community in crime prevention and safety related decision making. See the attached List of "Safety Reminder" examples.
 - c. All three "Safety Reminders" shall be relevant to the circumstances that prompted the Timely Warning.
 - d. When the Primary Officer's time is prioritized elsewhere, a secondary officer, a supervisor or the Lieutenant shall prepare the draft Timely Warning.
- 4. When practical, the Timely Warning Consultation Group shall review and finalize the Timely Warning.
- 5. Where appropriate, the victim shall be notified of the Timely Warning prior to it being disseminated.
- 6. The Chief of Police or designee shall email the approved Timely Warning to the campus community.
 - a. The Text of the Timely Warning shall be written into the body of the Email to ensure ADA compliance. This can be accomplished by copying and pasting a Word document text into the body of the email. A PDF Document of the Warning suitable for printing and dissemination/posting shall also be attached to the email.
 - b. The Timely Warning email shall come "From" the "University Police Department" via University Outlook email account. The sender must select the email address UniversityPolice-noreply@csusb.edu from the "From" dropdown menu.
 - c. The Timely Warning Email shall be addressed to the email List Serves: colleagues@groups.csusb.edu and students@groups.csusb.edu.
- 7. The UPD management team shall evaluate the need for additional forms of notification as specified in UPD Policy Section 808.4.
- 8. The Support Services Supervisor or designee shall post the Timely Warning to the University Police Department Web Page.
- 9. Updates, to the Timely Warning shall be disseminated as necessary.

Clery Geography Definitions:

On-Campus: Any building or property owned or controlled by the institution within the same reasonably contiguous geographic area and used by the institution in direct support of, or in a manner related to, the institution's educational purposes OR that is frequently owned by the institution but controlled by another person, is frequently used by students, and supports institutional purposes (i.e. a food or other retail vendor).

On-Campus Residence Halls: Any building or property owned or controlled by the institution within the same reasonably contiguous geographic area (within one mile) and used by the institution in direct support of, or in a manner related to, the institution's educational purposes, *including residence halls*.

Non-Campus Property: Any building or property owned or controlled by a student organization that is officially recognized by the institution; OR any building or property owned or controlled by the institution that is used in direct support of, or in relation to, the institution's educational purposes, is frequently used by students, and is not within the same reasonably contiguous geographic area (within one mile) of the institution.

Public Property: All public property (property owned by a public entity, such as a city or state government), including thoroughfares, streets, sidewalks, and parking facilities, that is within the campus or immediately adjacent to and accessible from the campus (sidewalk-street-sidewalk).

California "Serious" Felony Offenses relevant to Clery and Timely warning analysis:

PC 1192.7: Includes murder or voluntary manslaughter; rape; sodomy by force, violence, duress, menace, threat of great bodily injury, or fear of immediate and unlawful bodily injury on the victim or another person; oral copulation by force, violence, duress, menace, threat of great bodily injury, or fear of immediate and unlawful bodily injury on the victim or another person; lewd or lascivious act on a child under 14 years of age; any felony punishable by death or imprisonment in the state prison for life; any felony in which the defendant personally inflicts great bodily injury on any person, other than an accomplice, or any felony in which the defendant personally uses a firearm; assault with intent to commit rape or robbery; assault with a deadly weapon or instrument on a peace officer; arson; exploding a destructive device or any explosive with intent to injure; exploding a destructive device or any explosive causing bodily injury, great bodily injury, or mayhem; exploding a destructive device or any explosive with intent to murder; any burglary of the first degree; robbery; kidnapping; attempt to commit a felony punishable by death or imprisonment in the state prison for life; any felony in which the defendant personally used a dangerous or deadly weapon; selling, furnishing, administering, giving, or offering to sell, furnish, administer, or give to a minor any heroin, cocaine, phencyclidine (PCP), or any methamphetamine-related drug, as described in paragraph (2) of subdivision (d) of Section 11055 of the Health and Safety Code, or any of the precursors of methamphetamines, as described in subparagraph (A) of paragraph (1) of subdivision (f) of Section 11055 or subdivision (a) of Section 11100 of the Health and Safety Code; any violation of subdivision (a) of Section 289 where the act is accomplished against the victim's will by force, violence, duress, menace, or fear of immediate and unlawful bodily injury on the victim or another person; any felony offense, which would also constitute a felony violation of Section 186.22; assault with the intent to commit mayhem, rape, sodomy, or oral copulation, in violation of Section 220; throwing acid or flammable substances, in violation of Section 244; assault with a deadly weapon, firearm, machinegun, assault weapon, or semiautomatic firearm or assault on a peace officer or firefighter, in violation of Section 245; assault with a deadly weapon against a public transit employee, custodial officer, or school employee, in violation of Sections 245.2, 245.3, or 245.5; commission of rape or sexual penetration in concert with another person, in violation of Section 264.1; continuous sexual abuse of a child, in violation of Section 288.5; any attempt to commit a crime listed in this subdivision other than an assault; any violation of Section 12022.53; a violation of subdivision (b) or (c) of Section 11418; and any conspiracy to commit an offense described in this subdivision

PC 1192.8: When any of these offenses involve the personal infliction of great bodily injury on any person other than an accomplice, or the personal use of a dangerous or deadly weapon.





Timely Warning Personal Safety Reminders *Include for all Clery Crimes where TW's issued*

Generic

- Stay alert to your surroundings.
- If on campus after dark, use the University Police escort services. Dial (909) 537-5165 or 7777.
- IMMEDIATELY report suspicious activities, persons, and vehicles to the University Police.
- Walk with friends or in a group.
- Use well-traveled, well-lit routes.
- Don't listen to music or text while walking.
- Be aware of the CSUSB Blue-Light Emergency Phones and where they are on your route.
- Walk confidently, with a purpose, and at a steady pace.
- If you do find yourself in trouble, attract attention to yourself in any way you can.
- Don't be predictable. This can prevent someone from learning your routines and using them against you.
- Send UPD real-time, anonymous tips that can include audio, pictures, text, and or video via the LiveSafe App.

Robbery

- Stay alert to your surroundings.
- Activate SafeWalk through the LiveSafe App during your trip so that friends or family can view your step-by-step progress on a map. Deactivate SafeWalk after your trip.
- Walk with friends or in a group.
- Use well-traveled, well-lit routes.
- Don't listen to music or text while walking (or running).
- Don't be predictable. This can prevent someone from learning your routines and using them against you.

Burglary

- Always keep your doors and windows locked.
- Always lock up your car.
- Do not leave valuables in your car in plain view.
- Do not leave valuables unattended/out in the open.
- Do not let others follow you into your housing complex.
- Do not advertise that you will not be in your room for an extended period of time.
- Don't be predictable. This can prevent someone from learning your routines and using them against you.

Motor Vehicle Theft

- Always lock your car, even if you are away only for a moment.
- Do not leave valuable in your car in plain view.
- Never leave your car running while unattended.

Aggravated Assault

- Stay alert to your surroundings.
- IMMEDIATELY report suspicious activities, persons, and vehicles to the University Police.

- Report incidents of violence (including coercion) to law enforcement and campus authorities.
- No one deserves to be assaulted or victimized in any way.

Arson

- Stay alert to your surroundings, especially during heightened fire alerts.
- IMMEDIATELY report suspicious activities, persons, and vehicles to the University Police.

Sex Offenses (Rape, Fondling, Incest, & Statutory Rape)

- No one deserves to be assaulted or victimized in any way.
- You have the right to feel safe and say "NO" and not feel guilty.
- Be assertive and direct with someone who is sexually pressuring you.
- Never leave a party with someone you don't know well and trust.
- Trust your feelings; if it feels wrong, it probably is.
- Clearly communicate limits to partners, friends, and acquaintances.
- Don't mistake submission or silence for Affirmative Consent.
- Call Victim Connect at 1-855-4VICTIM (1-855-484-2846), the National Domestic Violence Hotline at 1-800-799-7233 or the National Sexual Assault Hotline at 1-800-656-HOPE (1-800-656-4673).

Domestic Violence

- Report incidents of violence (including coercion) to law enforcement and campus authorities.
- Discuss Sexual Misconduct, Domestic Violence, and Stalking with friends speak out against non-consensual sex or violence and clear up misconceptions.
- Call Victim Connect at 1-855-4VICTIM (1-855-484-2846), the National Domestic Violence Hotline at 1-800-799-7233, or the National Sexual Assault Hotline at 1-800-656-HOPE (1-800-656-4673).

Dating Violence

- No one deserves to be assaulted or victimized in any way.
- Report incidents of violence (including coercion) to law enforcement and campus authorities.
- Call Victim Connect at 1-855-4VICTIM (1-855-484-2846), the National Domestic Violence Hotline at 1-800-799-7233, or the National Sexual Assault Hotline at 1-800-656-HOPE (1-800-656-4673).

Hate Crimes (Federal Definition)

- No one deserves to be assaulted or victimized in any way.
- IMMEDIATELY report suspicious activities, persons, and vehicles to the University Police.
- Report incidents of discrimination or hate crimes to UPD or any campus authority.
- Set a good example to others by showing respect through your words, actions, and attitudes.
- Offer your support to a classmate or co-worker who has been the victim of a bias-motivated crime.

Stalking

- Any acts of criminal activity, including stalking, can be reported by dialing 911 or contacting UPD at 909-537-7777.
- No one deserves to be stalked or victimized in any way.
- Trust your instincts. Don't feel pressured by friends or family to downplay the stalker's behavior; stalking poses a real threat. Your safety is of utmost importance!

- Discuss Sexual Misconduct, Domestic Violence, and Stalking with friends speak out against non-consensual sex or violence and clear up misconceptions.
- Keep a record or log of each contact, no matter how small.
- Save all emails, text messages, photos, and postings on social media; this is evidence of the stalking behavior.
