#### **Creating Inclusive Digital Communities**

#### **Dr. Krystal Rawls**, Ph.D., Workforce Integration Network (WIN) Director, California State University, **Dominguez Hills**

Dr. Krystal Rawls is a seasoned educator and WIN Director at California State University, Dominguez Hills. She earned her Ph.D. from Claremont Graduate University and holds a Master of Arts in Higher Education: Student Affairs from the University of the Pacific along with a dual bachelor's degree from the University of California, Berkeley. With extensive experience in organizational readiness, digital inclusion, and innovative program development, Krystal has led initiatives that empower diverse populations to overcome barriers in the digital era. Her work integrates evidence-based practices to support community engagement and workforce integration.

"Creating Inclusive Digital Communities" is an evidence-based workshop designed to empower mental health professionals to bridge the digital divide impacting older adults and other vulnerable populations. Participants will learn to identify and overcome digital literacy barriers, implement intergenerational mentorship models, and design culturally responsive digital training programs. By the end of this one-hour session, attendees will have clear, measurable strategies to enhance their practice and support community engagement, ultimately contributing to improved client outcomes and societal well-being.

**Educational Goals**: This course is designed to enhance professional growth by improving understanding of how digital literacy and inclusive technology practices can strengthen social connectivity, reduce isolation, and support mental health. It aims to equip professionals with practical strategies for integrating digital skills training into their practice, ultimately contributing to improved client outcomes and community resilience.

**Learning Objectives**: By the end of this one-hour course, participants will be able to:

- List at least four key digital skills that support workforce inclusion
- Identify two benefits of intergenerational mentorship in enhancing digital competence
- Explain three strategies to overcome digital literacy barriers among older adults
- Outline a culturally responsive digital training program that meets the needs of diverse populations

# Cal State Research on Cognitive Impairment Funded by the National Institutes of Health (NIH)

**Dr. Eric Vogelsang,** *Professor and Director, California State University, San Bernardino (CSUSB), Center of Aging* **Dr. Jacob Jones**, *Professor, CSUSB* 

Dr. Eric Vogelsang will discuss his latest research linking social participation to cognitive decline among older adults. Attendees will learn about the limitations of current research and how his grant aims to address these limitations. Attendees will learn how "not all social activities are created equal" and how some activities may be more impactful when it comes to cognitive well-being. Attendees will also learn how social participation changes across mid-life and older ages.

Dr. Jacob Jones will discuss various topics on cognitive impairment among individuals with Parkinson's disease, such as neuropsychological methods for classifying stages of cognitive impairment and the potential role of the microbiome.

#### **Compassion and Care: Interpersonal Skills That Promote Wellness and Connection**

Financial fitness for seniors helps older adults gain an understanding of financial literacy, recognize the risk factors for exploitation, and learn to make more informed financial judgments. The path to economic security begins with basic money management, proper budgeting, avoiding scams, navigating the internet, and applying for benefits that can help seniors stay secure and independent longer.

## Workshop N

#### **Medi-Cal Basics and Beyond**

The Medi-Cal Basics workshop provides an overview of California's Medicaid program, covering eligibility, benefits, application processes, and recent policy updates. Participants will learn about income requirements, managed care plans, and services covered, including medical, dental, and mental health care. The session includes guidance on enrollment, renewal, and navigating common challenges. Ideal for individuals, caregivers, and service providers, the workshop offers practical insights and resources to maximize Medi-Cal benefits. Attendees will learn about the nationwide adopted Blue Envelope Program, which is designed to serve as a communication tool between law enforcement and community members during an interaction. This initiative promotes inclusivity by providing a recognizable blue envelope that contains an individual's identification, contact information, and vehicle documents. When the blue envelope is presented during interactions, it alerts law enforcement to the need for additional accommodation. The program also fosters trust and understanding which ensures safer and more effective interactions.

#### **Anatomy of a Scam**

#### Karen Rossi, Senior Financial Fraud Specialist, Council on Aging Southern California

Karen Rossi has been with the Council on Aging Southern California for 10 years. She specializes in elder financial abuse, scams and fraud. She is also the community liaison for scam and fraud education. Karen is a member of the Financial Abuse Specialist Team (FAST) in Orange County which is a Multidisciplinary Team of professionals who work in the senior demographic as well as the newly formed Adult Protective Services Multidisciplinary Team which reviews difficult fraud/scam cases. She is a graduate of the Federal Bureau of Investigation (FBI) Citizens Academy Class of 2022 and partners with the FBI in community education. Karen recently taught two classes for the University of California, Irvine (UCI) Osher Lifelong Learning Institute (OLLI) program which is UCI's older adult continuing education program.

"Anatomy of a Scam" was designed to educate about the common elements and the red flags of scams and the growing issue of cybercrime targeting older and dependent adults. We will introduce the four elements present in all scams, the many impairments and circumstances that make older and dependent adults targets of abuse and exploitation, discuss what attendees can do to empower clients and participants to protect themselves from abuse and exploitation and assist them in recovery from abuse and exploitation. We will also highlight the growing incidence of cybercrime targeting older adults for financial abuse.

**Educational Goals**: The participants will recognize the elements present in all scams and identify potential scams and financial exploitation affecting clients/participants/family and friends of clients/participants.

**Learning Objectives**: By the end of this one-hour course, participants will be able to:

- Identify the four common elements of all scams
- Identify at least three vulnerabilities affecting older and dependent adults, making them more susceptible to abuse and/or exploitation
- Identify the behavioral indicators of potential abuse and/or exploitation

This workshop provides an in-depth look at the home and community-based waiver programs, highlighting their role in helping individuals transition from healthcare facilities to independent, community-based living in light of the increased waitlist times to enter the ALW program. Participants will explore essential services such as housing navigation, care coordination, home modifications, and assistive device provisions. Additionally, the workshop will examine how to support individuals in maintaining stability while awaiting waiver approvals under the California Advancing and Innovating Medi-Cal initiative. Attendees will gain insight into eligibility criteria, referral processes, and the impact of reducing institutionalization and promoting independence.
