June 30, 2024. The audit was conducted in accordance with Generally Accepted Auditing Standards (GAAS) and Government Auditing Standards. Utilizing a risk-based approach, the audit focused on key areas including cash and investments, revenue recognition, capital assets, leases, payroll, and pension obligations.
