Through robust internal controls, annual independent audits, and disciplined risk management, UEC safeguards funds while enabling innovation, timely implementation, and measurable outcomes. This governance model accelerates research translation to community impact—advancing equity, student success, and data-driven solutions across the Inland Empire and beyond.
