## IV. University Report

President Morales provided his report to the Board. He thanked them for their support, especially in light of the current environment. He reported on how CSUSB shifted in March in response to new learning modalities, while ensuring the safety of students, faculty and staff. The Board commended President Morales and Cabinet for their quick action and response during the situation.

## V. Foundation Report

Nava reported on the most up-to-date fundraising numbers. Currently, the development team stands at about 90% towards reaching their fiscal year goal. During the past few months, there was also an effort towards an emergency COVID fund, which has raised over \$100,000 from both foundations and individual donors. This fund is also geared towards helping students with technology support, such as internet access or equipment loans. Recently, there was a \$500,000 gift from a new donor to provide support equipment for the College of Natural Sciences, and to provide hot meals and food. Nava affirmed to the Board that they will continue to stay engaged with the campus, and be updated as new situations develop.

## VI. Committee and other reports

#### 1. Advocacy Report

Monville provided an advocacy update. He reported that last Thursday, Governor Newsom released his May Revise, as an update to January spending proposal for the state for the coming year. The May Revise reflects the state's projected \$54.3 billion budget deficit caused by the COVID-19 pandemic. He reported that higher education institutions across the country, including CSUSB, are advocating for an additional \$47 billion in relief funds to help manage the impacts of the pandemic to students and campuses.

#### 2. Investment Committee Report

Breller from Beacon Pointe provided a market summary based on the economic indicators once the pandemic started, which was that they were willing to spend and were largely unemployed. That has now changed, leading to a real economic crisis with unprecedented jobless claims, but he mentioned that the Federal Reserve has been motivated to support the economy in terms of fiscal, monetary stimulus.

#### 3. Revised Procurement Policy

Alejandre mentioned that this revised procurement policy is different from the one presented electronically in March, as it aligns the Philanthropic Foundation policy with the state guidelines. There were some concerns raised on the threshold for quotes, as some felt the limits were too high for the Executive Director to review; Alejandre explained that the revision was made to have the procurement director sign off on all purchases, to provide checks and balances to the Executive Director.

Motion to approve the revised procurement policy as presented (Savage/Averill/Unanimous).

## 4. FY 20/21 Foundation Budget

There was a question on the line item for Board Development software, and that was to be for the implementation of board management software, so that directors can interact in a more integrated fashion with each other, and with documents. A follow up link will be sent with proposed board management software and demos.

Motion to approve the FY 2020-2021 Philanthropic Foundation Budget as presented (Averill/Savage/Unanimous).
