The meeting was called to order by the President, Bryce Davis at 12:05 p.m.

APPROVAL OF THE MINUTES:

REPORTS:

President: Mr. Davis stated that he met with the Leadership Challenge Course Ad Hoc Committee last Friday where they decided to use the funds for trees and plants, a new fence with a wind screen, engineered wood fibers for grounding and storage areas.
