APPROVAL OF THE MINUTES:

The minutes of August 26th were approved.

The minutes of the August 29th emergency meeting were approved.

REPORTS:

President: President Galvez stated that she is preparing for CSSA and CSUnity this weekend. She met with Mr. Vega to discuss hosting an open forum. She reminded Board members to schedule a meeting with her to discuss their goals and objectives. She deferred to the following: Mr. Gonzalez gave a detailed report on behalf of legislative affairs.
