#### Welcome

Greetings and introductions were made around the room.

#### A. Call to Order

Ellen Weisser called the meeting to order at 6:30p.m. Self-introductions were made around the room.

## B. Approval of the Agenda

## **Approval of the minutes**

<u>Motion</u>: The minutes of the March 21, 2019 Board of Directors meeting were reviewed and approved as written (Averill/Freer/Unanimous).

Committees: Fundraising, nominating, board development

#### C. Board Action

<u>Motion</u>: Approval of two new board members: Ms. Sarai Maldonado and Mr. Justin Swant (Stevenson/Chen-Maynard/Unanimous).

### IV. Committee and other reports

#### 1. Executive Director Report

Executive Director Nava thanked the Philanthropic Foundation Board for joining this meeting.

To formalize the meeting, the Foundation will provide nameplates for directors, and provided a gavel for the Chair. Nava thanked Hendry and Oliphant for attending from PDC. He shared the hospitality event yesterday, and reported that there are lots of exciting initiatives underway at PDC (cybersecurity, hospitality, nursing, entrepreneurship), and that Dean Zhu comes onboard in July.

AVP Shiner and her team working closely with deans have been busy engaging donors and prospects to convey the message about CSUSB. Currently to date Development has raised \$6.3 million, and that there was great success with first ever campaign. Over the course of the summer, cabinet, deans and academic leadership will have conversations as to what the next campaign will look like and focus on, as well as how to celebrate the success of this campaign.

#### 2. Financial Review

Badulis directed members to the Statement of Financial Position and highlighted variances between 2018 and 2019. As of March 31, 2019. She highlighted Cash and Cash Equivalents at \$5.3 million which is due to a cash influx from the endowment distribution. Long-Term Investments are down about \$4 million showing a market downturn for 4<sup>th</sup> quarter of calendar year 2018. Badulis assured that the 1<sup>st</sup> quarter of 2019 looks better. Members were asked to view the Statement of Activities next which showed that Contributions – Temporarily Restricted,

or gifts, passed last year's level and is at \$2.9 million and Investment Income is up by \$700,000. Badulis shared that Expenses are stable at \$1.6 million.

## 3. Investment Committee Report

Stevenson invited members to the Investment Committee Report and highlighted the Total Composite as of the end February which is just under \$39 million. He expressed that the portfolio is built to achieve growth with significantly less risk so the advantage to the market downturn in December is where the downside protection comes into play. In comparison, the index was down by 9.2% while CSUSB's portfolio was down 7.5% for last quarter, showing that the portfolio is properly positioned.

Stevenson shared that the Request for Proposal process resulted in keeping Beacon Point Advisors. Freer added that 11 proposals were submitted with six finalists. A meeting was held to discuss current service, fees and communication.

## 4. Alumni Report

Stevenson directed members to the written Alumni Report and highlighted various events, such as The Alumni Professor for a Day luncheon held on Wednesday, May 8. More than 100 participants attended the luncheon, with over 110 alumni matched to a class. Other exciting events are underway, including various chapter activities.

## 5. Advocacy Report

Langford directed members to the Advocacy Committee Written Report. She highlighted the recent Sacramento trip to advocate for budget for CSUSB and the CSU system which was different compared to prior years under a new Governor. Edwards shared that Governor Newsome has proposed a \$562 million baseline increase in funding, largest increase in CSU history which will fund a 2% increase in enrollment. Edwards invited members to join the efforts of the Advocacy Committee and shared that we are optimistic about the May re-write.

## V. New Business

#### a. 2019-2020 Annual Budget

Alejandre walked the Board through the proposed budget for 2019-20 including operating expenses, operating revenues and reserves based on review from Chancellor's Office and recommendations from advisory report.

Stevenson reviews the endowment distribution sheet that shows the Board what the scholarship distribution is.

Weisser informed the board meeting members about the Board of Directors Meetings dates, the Executive Committee Meetings dates and the Investment Committee Meetings dates. Weisser again emphasized the AGB Conference in San Diego.
