Chair Mark Edwards called the regular meeting of the CSUSB Philanthropic Foundation Board to order at 3:11 p.m.

The board and guests joined in a moment of silence in honor of Lois Carson.

The consent agenda, including the June 17, 2021 CSUSB Philanthropic Foundation Board meeting minutes and the Alumni Board report, was approved as distributed.

President Morales gave a report on the state of the university, including an update on capital projects and news of upcoming academic programs: the School of Criminology and Criminal Justice; the Department of Child Development; and the Master of Science, Physician Assistant program.

A report was given by Vice President Paz Olivérez on the return to campus from the perspective of the Division of Student Affairs, followed by a report from Daisy Ramos on behalf of the Associated Students, Inc.

A report was given by Mark Edwards on behalf of the Audit Committee. Acting on behalf of the Executive Committee, Mr. Edwards then presented Dr. Manish Patel as a nominee for membership on the CSUSB Philanthropic Foundation board. Ellen Weisser moved that Dr. Patel be admitted to membership, and the motion was adopted. Mr. Edwards introduced the new student, staff, and alumni board members.

Robert Nava introduced new advancement staff to the board and then gave a presentation on The Campaign for CSUSB: Our Defining Moment, including the campaign vision, a definition of the blended campaign, areas for support, the working goals, and a discussion of next steps for board involvement.

Reports were given by Mr. Edwards on behalf of the Advocacy Committee and Gary McBride on behalf of the Investment Committee.

Monica Alejandre presented the revised 2021-22 foundation budget.

Dean of the College of Arts and Letters Rueyling Chuang, Department Chair and Professor of Music Stacey Fraser, Department Chair and Professor of Theatre Arts Terry Smith, music student Kimberly Benavides, and theatre arts student Isabel Peña provided the board with an update on performing arts at CSUSB.

President Morales and Mr. Edwards honored Ellen Weisser for her many years of service to the university and the Philanthropic Foundation Board. Following the presentation, music students Kimberly Benavides and Christian Quevedo enthralled the board and guests with performances from two operas.
