Description of Outcomes for incidents with no investigation		
Stalking	Non-Affiliate	Student reported an ex-boyfriend was stalking her. Resources were given to student; UPD and Advocate.
Stalking	Non-Affiliate	Student reported an ex-boyfriend was stalking her. Resources were given to student; UPD and Advocate.
Stalking	Non-Affiliate	Student reported being stalked by a non-affiliate. The advocate and UPD was offered to assist her.
Stalking	Non-Affiliate	Vendor reported a staff member was being stalked by a non-affiliate/ex-partner. Workplace accommodations were offered by vendor and vendor relocated staff member to new location.
Stalking	Non-Affiliate	Student reported being stalked by a non-affiliate. University Police and the advocate were offered.
Stalking	Unknown	Complainant declined offers for assistance from Title IX. Title IX still offered resources and any assistance from the advocate as a resource.
Stalking	Non-Affiliate	Student reported being stalked by a driver of a ride-sharing app. Title IX coordinator offered to assist the student with filing a formal complaint with the app and to discuss ways to minimize contact with the non-affiliate.
Domestic Violence	Non-Affiliate	Complainant declined all assistance from Title IX, including that from the police.
Domestic Violence	Non-Affiliate	A student reported that she was involved in a domestic violence situation. Referrals to CAPS and the advocate were given. Student declined police assistance and housing accommodations.
Domestic Violence	Non-Affiliate	Student was offered resources from CAPS, filing a police report, given access to emergency housing, and ongoing case management follow-up with CARE. Additionally, academic accommodations were made.

Domestic Violence	Non-Affiliate	Student reported being involved in a domestic violence incident with a non-affiliate. The student was referred to the advocate for support and resources. Student declined restraining order/police support.
Domestic Violence	Unknown	Student reported to staff at PDC that she was involved in a domestic dispute off campus. Title IX gave student domestic violence resources for the PDC area, as well as a referral to the advocate.
Domestic Violence	Non-Affiliate	Student involved in a domestic violence dispute. Referalls to the adovate were given, and the CARE team assisted with accommodations.
Domestic Violence	Non-Affiliate	Title IX was informed of a staff member who was involved in a domestic dispute off campus. When Title IX reached out, the staff member declined any assistance and stated the situation had resolved itself. Title IX still gave the staff member a referral to the advocate.
Dating Violence	Non-Affiliate	A student reported being in a dating violence situation with a non-affiliate. Student requested assistance from the CARE case manager to help with long-term academic assistance.
Dating Violence^{x3}	Non-Affiliate	A student reported to housing on three separate instances dating violence incidents with a non-affiliate. During the first two incidents, the student declined assistance or to meet with Title IX. On the third incident, the student met with Title IX and declined the advocate and other accomodations.
Sexual Misconduct	Non-Affiliate	A student reported a sexual assault off campus by a non-affiliate. The student was referred to the advocate and filed a police report.
Sexual Misconduct	Non-Affiliate	A student reported being sexually assaulted by a non-affiliate in the past, and saw the respondent visiting a resident in her building. A housing accommodation was made and a no-contact order was given to the respondent's student/friend.
Sexual Misconduct	Faculty Member	A complaint was filed by a non-affiliated person regarding a faculty member. SBPD was notified and when Title IX contacted the complainant, the complainant stated she was not filing a complaint and did not want SBPD to look into the case.

Sexual Misconduct	Unknown	A student was sexually assaulted by an unknown person. Student declined assistance from the university, but was given a referral to the advocate.
Sexual Misconduct	Unknown	A student reported to an academic advisor, that he had been sexually assaulted by an unknown person. The student was offered support by the Advocate and wanted academic accommodations.
Sexual Misconduct	Unknown	A student reporting that she was sexually assaulted by an unknown person years ago. When Title IX reached out to the student, she declined to meet with the Title IX Coordinator or the advocate.
Sexual Misconduct	Unknown	A student reported that she has been having academic issues resulting from a previous sexual assault by an unknown person. The student wanted assistance from the Title IX office for academic accommodations.
Sexual Misconduct	Unknown	Non-affiliate reported a sexual assault that took place at an off campus party by an unknown individual. The case was being investigated by the SBPD.
Sexual Misconduct	Unknown	A student was sexually assaulted by a neighbor at an off campus apartment building. The student accepted assistance with the Advocate to contact the building management and to file a police report. Student declined emergency housing accommodations.
Sexual Misconduct	Unknown	Student reported a former sexual assault and issues with his academics as a result. Title IX met with and offered support to the student. Student declined academic accommodations. Referral to advocate.
Sexual Misconduct	Non-Affiliate	Student reporting being sexually assaulted by a non-affiliate off campus. UPD investigation; Advocate referral; Title IX assisted with transferring the student to a different CSU per his request.
Sexual Misconduct	Non-Affiliate	Student reported a sexual assault with a non-affiliate. Declined any assistance from Title IX; referral to the advocate.
Sexual Misconduct	Non-Affiliate	Student reported that a non-affiliate who had sexually assaulted her off campus in the past was seen on campus. The student was referred to the advocate and CAPS.
Sexual Misconduct	Non-Affiliate	Student reported having been sexually assaulted by a family member in the past. Student was offered off-campus resources, CAPS and the advocate as campus resources.

Descriptions for Investigations with Insufficient Evidence		
Domestic Violence	Student	Complainant chose not to participate during the investigation; insufficient evidence to substantiate allegations.
Sexual Misconduct	Student	Insufficient evidence to conclude that sexual misconduct occurred. No witnesses or additional evidence to corroborate claims.
Sexual Misconduct	Student	Insufficient evidence to conclude that sexual misconduct occurred. No witnesses or additional evidence to corroborate claims.
Sexual Misconduct	Student	Insufficient evidence to conclude that the intoxicated respondent knew or reasonably knew that the complainant was incapacitated at the time that they mutually engaged in sexual intercourse.
Sexual Misconduct	Student	Complainant did not give the respondent any verbal or non-verbal signals to let him know that she did not want to engage in kissing, and let him kiss her.
Sexual Misconduct	Student	Insufficient evidence to conclude the Complainant's allegations. Complainant stated she allowed the Respondent to have sexual intercourse with her so he would not be angry, but could not provide any instance when he was angry before or during the incident. Respondent provided detailed information on his relationship with the Complainant.
