# CURRICULUM DEVELOPMENT AND TEACHING INNOVATION

Innovative Course Design for CSP 645

This course was redesigned to provide school counseling graduates hands-on experience with high school students enrolled at Helix Charter High School. In lieu of a lecture-based format, graduate students participated in the after-school program, *College 101*, and supported identified first generation high school seniors through the college application process in order to increase the number of students who apply, enroll, and matriculated into college. School counseling students were assigned a case load of high school seniors to support through their application process. The instructor also guides graduate student learning through lectures, feedback, and weekly reflections.

# Innovative Course Assignment for CSP 710A

*Professional Website:* For this assignment, students designed and created a professional website to showcase their evidence of meeting the competence within the California Commission on Teacher Credentialing School Counselor Specialization Standards. Through the use of a webbased portfolio, students are able to reach a larger audience by including the website link to social media accounts, job applications and/or email signature. The professional website builds on previous paper-based and/or LiveBinder portfolio format previously used.

# Innovative Course Assignment for CSP 730

School Counselor (SC) Profile: For this assignment, students were required to complete a School Counselor (SC) Profile website for their fieldwork sites. The SC Profiles allows students to create a website that will showcase the counseling program of their fieldwork sites. A complete website includes a principal's message, academic and career development interventions implemented, community partners and programs, the school counseling program team and unique features of the school counseling program such as data outcomes. Final "high quality" profiles will be featured on the California Association of School Counselors (CASC) website, further advancing students' presence in the school counseling community.

# Innovative Course Assignment for CSP 742

ASCA Position Statement Feedback Submission: For this assignment, students reviewed one of the position statements open for public comment and provided suggestions based on their knowledge of the ethical and professional standards, laws, policies and/or other information as it relates to school counseling and/or education. Upon selecting a position statement, students examined a position statement and its relevancy to the inclusion of ethical and professional standards, legal statues and its relevancy to state, district, and school level policies. As an outcome, submitted comments by several school counseling students were adopted into current position statements posted on the ASCA website.

Innovative Course Assignment for CSP 762

Youth Mental Health First Aid Training. Students completed the YMHFAT, which is designed to teach parents, family members, caregivers, teachers, school staff, peers, neighbors, health and human services workers how to help an adolescent (age 12-18) who is experiencing a mental health or addictions challenge or is in crisis. This course requirement was designed to increase student's knowledge of general common mental health challenges for youth, review of typical adolescent development, and how use the 5-step action plan for how to help young people in both crisis and non-crisis situations.

Trauma-Informed Practices for Schools (TIPS) Training. The course requirement allowed students to gain greater understanding of the physiological impacts of trauma on the brain and impacts on student behaviors and ability to learn. Students gained a general understanding of the lifelong impacts of trauma for students if left untreated and why it's important to create trauma sensitive learning environments.
