## **Consent Items**

## **Executive Director Report**

Nava directed committee members to the Philanthropic Productivity Report at \$8M, and reported that the general obligation bond is moving quickly through the senate. He also reported that the Investment Committee is doing heavy work in reviewing the portfolio, and in an upcoming meeting, will be reviewing the investment policy statement to ensure that it aligns with the current market.

## **Financial Review**

Badulis reviewed the Statement of Financial Position and of Activities. The committee had no areas of concern.

# Review committee structure

The committee reviewed and approved the consent calendar, with the intention that items will be pulled for discussion as the need arises. This new format will be used for the Board of Directors meeting, for discussion and approval of the full Board.

Nava mentioned that there will be standing committee that will review the bylaws, in order to bring them up-to-date, and so they are current with the Board and its needs as they stand today.

Nava provided an update on the upcoming AGB Conference, scheduled for January 2020. Various members of the Executive Committee will be in attendance, and it will be an informative conference for those involved.

# Action Items

Langford provides as update on Proposition 13, and stressed to the Board that CSUSB cannot take a position, but can participate in coordinated educational campaigns designed to inform and educate the public, and that the bond is meant to ensure students have safe and healthy environments. Langford and the Advocacy Committee, sought the Board's resolution of support for Proposition 13.

**Motion:** Approval of Resolution of Support: Proposition 13, the Public Preschool, K-12, and College Health and Safety Bond Act of 2020 (*Stevenson/Jackson/Unanimous*)
