IRS Data Retrieval Tool Instructions

1. Log into your FAFSA with your FSA ID & Password as a Returning User at <u>www.fafsa.gov</u> to update your and/or parents/spouse income information.

2. Click on the "Make FAFSA Corrections" link at the bottom of the next page.

3. Click on the "Financial Information" tab to update the student tax information or the "Parent Financial Information" tab to update the parent tax information.
