#### **MINUTES**

#### APPROVAL OF THE MINUTES:

#### REPORTS:

College of Education: Ms. Milian stated that an open forum will be held for the College of Education on February 6<sup>th</sup> at 5:30 p.m. and on February 10<sup>th</sup> at 7:30 a.m.

College of Natural Sciences: Ms. Tran stated that an open forum will be held for the College of Natural Sciences on February 15<sup>th</sup> from 12-2 p.m.

## BD 01-18 M/S Felix/Azhand: Approval of the BOD Incentives Policy.

## Section 5: Resignation, Removal or Failure to Fulfill Expectations and Requirements

A: Directors that resign, are removed from office or fail to fulfil their obligations as outlined in section one of this policy will be required to full reimburse the Associated Students Incorporated by the end of the quarter/semester.

B: Should a student director fail to reimburse ASI for the incentive provided by this policy, the ASI Executive Director will begin the process to withhold enrollment or transcripts, as appropriate, until the debt is satisfied.

C: Special circumstances. Should special circumstances prohibit the director from fulfilling their obligations, the ASI Executive Director reserves the right to waive the reimbursement referenced in section four of this policy.
