M/S Felix/Ruiz to open Action Item PP 014/22 revision of SMSU Travel Policy to update per diem amounts in Section 103 B Subsection b to increase by \$5 per meal due to current national inflation rates.

Discussion ensued regarding increasing the per diem amounts for travel by \$5 per meal. Discussion and debate regarding utilizing the US General Services Administration Rates for per diem. Decision on wording to be "The amounts utilized for travel per diem are to be in accordance with that set forth by the US General Services Administration."

Discussion ensued regarding revising the SMSU Travel Policy to reflect consistency with CSUSB Travel Procedures for round trip travel. Currently staff are reimbursed round trip but only in excess of their normal commute. SMSU current travel policy is confusing and is not an equitable policy.

The group was unable to come to a decision therefore the motion is tabled indefinitely.
