

### **General Comments**

 FAM's were vetted by the FAC and EC and consensus achieved.

 Review: FAM 652.4 (FAM 300) and FAM 820 (FAM 320) proposed changes



### FAM 652 (FAM 300) Page 10 Lines 10-39

- 4. a. Consistent with CBA
  - Subsections (SS) i iii defines courses that are exceptions to use of SOTE
  - SS iv continues a CSUSB policy for first year faculty

 4. b. Exempt courses should use alternative SOTE forms

### FAM 652 (FAM 300) Page 10 Lines 10-39

- 4. c. Policy waiver for those judged as "excellent teachers that are above expectations in teaching"
  - SOTE 50% of representative classes
  - Time frame for the joint decision on courses to SOTE no later than the 4<sup>th</sup> week
  - Procedure to address disagreements on courses to <u>SOTE-</u>
- 4. d. Auditor of the 50% policy

### FAM 652 (FAM 300) Page 20 Lines 14-18

 A statement about periodic evaluation time schedule for 3-year temporary faculty members. The change is consistent with the CBA.

### FAM 652 (FAM 300) Page 31 Lines 25, 32, & 34

 Deletion of the word "Full" for more parsimonious language

### FAM 652 (FAM 300) Page 38 Lines 29 – 48 & Page 39 Lines 1-2

- Section II, Part:
- A Time schedule for Periodic evaluation
- B FERP faculty may serve on DEC\*
- C FERP evaluation conditions
- D Protocol for handling periodic evaluations when number of faculty due for review exceeds 25%

Part F, #4 – language change:
 "opportunities for improvement."

 Identify teaching effectiveness as excellent or above expectations in periodic evaluation.

### **Update**

- Page 10
  - Lines 18-20 "These shall not appear in the WPAF unless requested by the faculty member."
  - Lines 22-24 Faculty members teaching courses with field experiences, thesis research, independent project/study, internships, distance learning through interactive televised video; recitations, and, teamtaught courses are encouraged to use alternate evaluation instruments.

## Update (continued)

- Page 10 lines 37-39
  - The College Dean or her/his designee will maintain a record of the faculty members that qualify for the condition to survey at least 50% of the classes they teach in accordance with Chapter 1, Part II Evaluation, Section D, Number 4. C.

# Update (continued)

- Page 14 lines 2-4 Delete
- Page 38 lines 30-32 replace to read:
  - Such periodic evaluations shall be conducted jointly by the DEC and the Chair.
- Page 39 lines 30-31
  - The report shall make note of whether or not the faculty member is considered to be excellent or above expectations with respect to teaching effectiveness

#### Recommendations

- Support the first reading of the document with the updated changes.
- FAC will review proposed statements as per the updated comments.
- Recommendations will be presented at the next FS meeting for a second reading.
