Contracting with AnyTime Fitness for student use at PDC Campus. New building is in discussion, currently there is no bond debt for PDC which helps with new construction. Approved for construction of a Student Center which will include 3800 square feet for RecWell Center. Groundbreaking will occur in 2025 with an estimated open date of 2027. PDC could use a grant writer to take advantage of funds from such foundations like Kellogg who focuses on wellness. Having a grant writer to help subsidize the costs of a RecWell Center at PDC will help in determining the rates for the new building.
