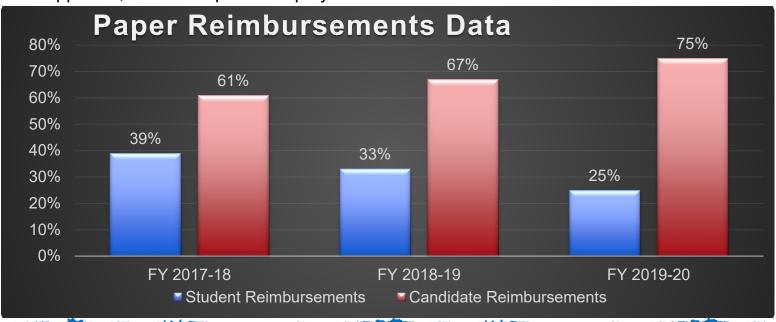

Assessment Methodology

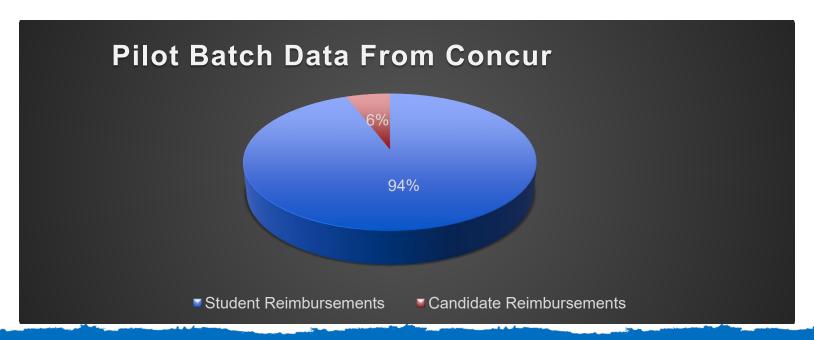
- We reviewed the number of paper reimbursement claims for both candidate and students for the last 3 Fiscal Years
- We started to review this process in January of 2020, but when the pandemic became apparent, we had to push this project forward





Assessment Data

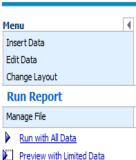
- We started with University Advancement
 - We created and tested 52 students reimbursements as a pilot batch
 - We created and tested 12 candidate reimbursements in the spring quarter (2020)

Assessment Findings

- Paper reimbursements outside of Concur are not accurately accounted for in reporting
- Paper reimbursements are a manual, labor intensive process
- Wet signatures were required
- Paper receipts were required, sometimes leading to missing or illegible receipts

Implications for Practice

- Reimbursements completed electronically in Concur are included in detailed Concur reporting
- Reimbursements in Concur are easier and more efficient
- Digital signatures eliminate the need to route paper documents to approvers
- E-Receipts, uploaded directly into Concur eliminate hard copy receipts and missing or illegible receipts
- Concur is able to archive information in the data warehouse making it easier to pull the records for auditors

- Looking toward the future
 - Create a "guest reimbursement" portal, which would allow a link to be sent to the candidate or student where they could enter their own data and upload their own receipts
 - This would eliminate a campus delegate from having to manage all the activity, such as logging data on behalf of the payee
 - The delegate would instead review the data entered and forward it for approval
