Call to Order: The meeting was called to order at 10:06 a.m.

Roll Call: A verbal roll call of attendees was conducted.

Approval of SMSU Board of Directors Minutes from May 11, 2017:

M/S Imeri/Friedman to approve the SMSU Board of Directors Minutes from May 11, 2017.

Motion passed.

Reports:

Ms. Hernandez Aguilar shared her gratitude for the opportunity to serve as Board Chair and recounted the major endeavors the Board accomplished this academic year.

Mr. Burgess shared his appreciation for the Board of Director's service this year and commented that the SRWC had over 250,000 visitors attend the facility over the last year. He also shared that the Student Union hosted over 1.5 million visitors and spent over \$1.1 million in student salaries.

Dr. Satterlund encouraged the Board to continue with their commitments to CSUSB and the Inland Empire. She also encouraged those on the Board to continue being engaged citizens and to be proud of the work they have done in transforming the campus through student leadership.

Mr. Gutierrez congratulated the Board for their role in setting the stage for the SMSU expansion and encouraged the incoming student leaders to continue sharing their talents with the community.

New Business:

SMSU 47/17 Recreation & Wellness Center/SMSU Policy Revisions (Action, Burgess)

M/S Imeri/Gutierrez to approve the Recreation & Wellness Center/SMSU Policy Revisions

Mr. Burgess discussed the recommended changes to the facilities policy to mirror the CSUSB policy regarding alcohol, tobacco, and drugs. Additionally, the Service Animals' policy has been expanded to include all emotional and support animals and defers to the CSUSB policy on service animals. The dress code policy has been revised to stipulate all visitors must have complete attire and shoes when entering the facility.

Rising count 11 - 0 -0. Motion passed.

SMSU 49/17 Recreation & Wellness Personal Training Rate Increases (Action, Burgess)

M/S Hernandez/Dickson to approve the Recreation & Wellness Personal Training Rate Increases.

Dr. Nester shared the rate increase proposal with the Board. Mr. Luna shared with the Board the justification of the rate increase recommendation; given the minimum wage increase, inflation and national certification requirement, a rate increase will avoid a compression between the personal training wages and minimum wage earnings.

Mr. Gutierrez inquired about the ratio of faculty to staff use for personal trainers, the response was that it is currently half and half. Mr. Imeri asked about current prices and retention rate for personal trainers. Dr. Satterlund inquired if an effective date of July 1st is an adequate amount of time to inform clients of the rate increase. Dr. Nester replied that the Recreation & Wellness

Department is open to changing the effective date of the increase. Ms. Hernandez asked how the Recreation & Wellness personal training rate compares to the surrounding areas rates. Mr. Luna replied that even with the rate increase, their rates are at the lower end. Mr. Gutierrez recommended a tier system with faculty paying a higher amount and the student rates remaining the same. Mr. Burgess echoed Mr. Gutierrez's recommendation of having a tier system where faculty and staff pay \$1 than students and changing the effective date to September 1, 2017.

Dr. Satterlund asked that a new proposal with the recommended revisions be presented to the Executive Committee in early July. Dr. Mendoza suggested that the committee also provide the Board with additional statistics regarding the proposal.

M/S Gutierrez/Imeri to table the discussion until the revisions to the proposal are reviewed by the Recreation & Wellness Committee.

Motion passed.

SMSU 48/17 SMSU Board of Directors Student Representative Position Interviews (Action, Hernandez Aguilar)

M/S Gutierrez/Perez to open the SMSU Board of Directors Student Representative Position Interviews.

Ms. Hernandez Aguilar explained the interview process to the applicants and shared that the results would be posted on the Board marquee at 2:00 p.m. and also sent via email. Mr. Burgess shared that the applicants that were accepted for Board appointments would be invited to join a meeting for the SMSU expansion on June 9, 2017 at 1:00 p.m. The following applicants spoke to their qualifications for the Board of Directors Student Representative positions: Dionely Acosta, Drew Allensworth, Fatima Alrazaa, Tejwant Brar, Jodi Buckley, Riane Castro, Dayanna Hernandez, Erika Ozuna, Derick Prince, Matthew Summerville, Tracie Ventimiglia, and Canshara Washington.

The following applicants were selected as alternates: Tejwant Brar, Dayanna Hernandez, Erika Ozuna, and Canshara Washington.
